We are excited to welcome you to TAE for the 2025-2026 school year and offer our After School Care (ASC) program! Attached is the 2025 - 2026 After School Care information and registration forms required for enrollment.

- Page 1 - ASC Program information - updated registration fees - please note payment due dates for monthly and drop in students
- Page 2 - 2025-2026 Registration Form - filled out and payment must be made before your student can attend
- Page 3 - Behavior Guidelines - Tiered behaviors that are not acceptable at ASC and may lead to sitting out increments of time during ASC or suspension from the program.
- Page 4 - Parent/Student Compact Form - Please be sure to review these expectations with your student. Must be signed by and returned before the student can attend

Students who begin in August registered as MONTHLY (daily) enrollee, WILL NOT make a December payment due to October, November, and March being short months. Monthly payment is due by the 20th of each month.

Students registered as DROP IN will follow the DROP IN rates August - May. Drop in payment is due by the 30th of each month.

TAE will not send a billing statement, so we ask that families make ASC payments in a timely manner. Accepted forms of payment include: Cash, checks payable to TAE, or with a debit/credit card through our online payment system on the Salado ISD website. Payments can be made at ASC pick up. If the payment is sent with your student, we ask that you place it in an envelope labeled Office/ASCP/Student Name to ensure it gets turned in safely.

An ASC table will be set up in the cafeteria at Meet the Teacher on August 11th, 2025 from 3:30pm - 5:30 pm. We invite you to stop by to enroll! If you care to come by campus prior to Meet the Teacher, our summer office hours are Monday - Friday from 7:30am - 4:00pm. ## 2025-2026 After School Care Program Behavior Expectations

In order to ensure a safe environment for all students participating in our after school care program, the Thomas Arnold Elementary (TAE) S.O.A.R. behavior expectations will be implemented during ASC. This includes all students being Safe, Organized, Accepting, and Respectful. The following are some Tiered Behaviors that if observed during ASC, may result in sitting out for increments of time from ASC.

### Tier 1 Behaviors:

Not following SOAR expectations	Profanity - Language, drawing, gestures, not directed at another	Minor aggression w/intent to harm	Non-compliance/insubordination
Inappropriate language	Leaving an area w/out permission	Disrespect of property	Unsafe, rough play or horseplay
Teasing others	Disrespect towards others	Dishonesty	Inappropriate use of technology

### Tier 2 Behaviors:

Profanity - Language, drawing, gestures *directed at another	Leaving an area w/out permission. repeatedly	Verbal or physical aggressions w/intent to cause harm	Vandalizing or damaging property, school or personal

### Tier 3 Behaviors:

Leaving campus	Fighting/Physical Aggression/Assault of Any Kind	Imminent damage to self or others	Repeating Tier 1 and 2 Behaviors

## 2025-2026 After School Care Program Parent/Student Compact

This compact form will serve as a contract/agreement between the ASC program, the student, and the parent. All students attending the ASC program will be expected to follow all Behavior Expectations. Violating behavior expectations during ASC may result in sitting out for increments of time from ASC as follows:

- Tier 1 behavior (1st offense) may result in sitting out 15 minutes  
Each additional tier 1 offense will add 15 min increments of sitting out
- Tier 2 behavior (1st offense) may result in sitting out 30 min  
Each additional tier 2 offense will add 30 min increments of sitting out
- Tier 3 behaviors will result in an automatic call home requiring parent pick up and dismissal from ASC for that day.

Parents will be contacted regarding any behavior expectation violations or concern. Repeat offenses may result in suspension/dismissal from the After School Care Program.
