As a senior, you are eligible for privileges that include permission to drive to school and park on campus in an assigned shared parking space. In order to take advantage of these freedoms, all paperwork and permission slips must be completed and on file in the main office. It is imperative that you provide the following materials so that the process of assigning student parking can begin as soon as school opens:

- **A copy of your valid driver's license.**
- **A copy of the vehicle registration.**
- **A signed Student Vehicle Information and Parental Consent Form.
(Included in this package)**
- **The name of the senior with whom you are sharing your parking space.**

All student drivers are expected to adhere to safety rules and regulations. Students are to act and drive in a responsible manner and to listen to and obey instructions from security officers, faculty and staff members. Students who abuse this privilege in any manner will have their privilege suspended/revoked. I am confident that the seniors will lead the way and be examples to the rest of the student body both in your level of maturity and the extent to which you accept responsibility.

Students who have completed the parking registration process will receive a parking pass. The tag, which designates the assigned parking space, is to be used only by the student to whom it is issued. Tags must be displayed at all times when parking at Blind Brook High School. Sharing, loaning, or failure to display the assigned tag will result in a loss of parking privileges.
