This plan also includes an embedded per member OOP maximum, which is set at the individual OOP maximum amount. Under this plan, deductible must be met before benefits will be paid (please see handbook for further details).

What is the Hillsboro Kaiser Preferred Plan, And Why Would I Sign Up For It?

In an effort to bring some of the best health benefits for classified employees in Oregon to Hillsboro School District, HCU's Preferred Plans are based on a Group Health Reimbursement Arrangement (HRA) concept. With the Group HRA, the District and HCU reduce the Kaiser 2B in-network deductible to \$0 and \$1,500 OOP. For Kaiser 3, the in-network deductible will be \$500 with a \$2,500 OOP for an individual.

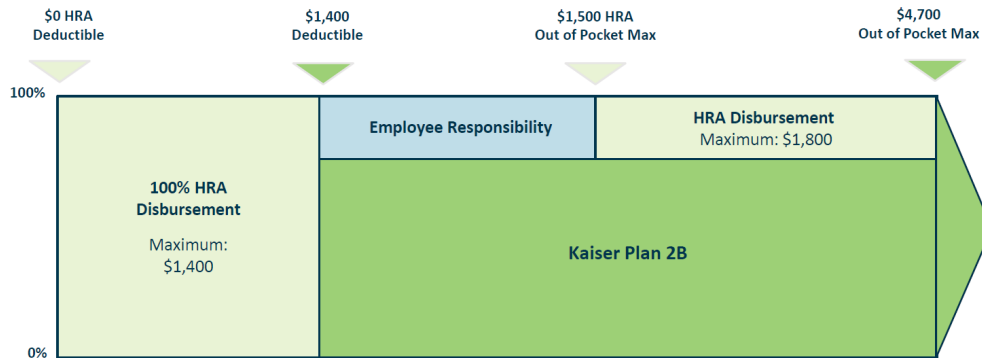

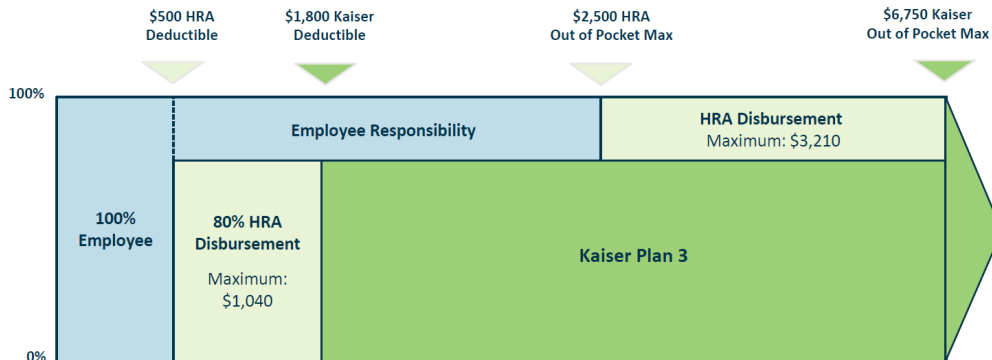
How Does It Work?

Please Note: For parties of 2 or More, the HRA Deductible will be \$1,000 and Out of Pocket Max will be \$5,000.

How Do I Sign Up?

Step #1: Enroll yourself (and your eligible dependent(s) if applicable) in Kaiser 2B or Kaiser 3 on the OEBC website.

Step #2: If you are new to the Preferred Plan, be sure to complete the Direct Deposit Application for HRA Reimbursements and return to Mae or the HSD Benefits Department by August 30, 2025.
