

Instructions For Prospective Students Who Are Applying For Admission To Wesleyan

Make sure you have completed the admission process before you complete the financial aid process.

Financial Aid Grants will be emailed to new students on April 4, 2026, with their admission packet. All responses to the financial aid information are due back by April 14, 2026. In order to be eligible to be considered for need-based financial aid, we must first have a complete financial aid file by **March 2, 2026**.

Please **submit or upload the following items to the School and Student Service for Financial Aid by the deadline** in order to have a complete financial aid application file:

1. **The PARENTS' FINANCIAL STATEMENT (PFS) that you complete online through the School and Student Service for Financial Aid (SSS) in Princeton. Be sure to use the Wesleyan School code (1495) on this application. You must complete the PFS online. Go to <https://sssandtadsfa.my.site.com/familyportal> and follow the online instructions. The cost to complete the PFS online is approximately \$60.**
2. **A true copy of your signed, 2025 Federal Income Tax Return (Form 1040 including ALL Schedules) that you sent to the IRS. No estimates will be accepted. You must file your taxes early in order to meet the March 2 deadline. You do NOT need to submit a copy of your state income tax return.**
3. **A true copy of your signed, 2024 Federal Income Tax Return (Form 1040 including ALL Schedules) that you sent to the IRS. Again, you do NOT need to submit a copy of your state income tax return.**
4. **A copy of all W-2 Forms for both 2025 and 2024. If you are a consultant, a copy of all 1099 forms for both years. If self-employed include any business income tax returns appropriate for each year.**
5. If you are divorced, separated or have never been married, the custodial parent (and present spouse, if one) should send the PFS to the SSS in Princeton as described above. The non-custodial parent must also complete a separate PFS and submit it to the SSS in Princeton. The non-custodial parent must also submit a copy of their 2025 and 2024 Federal Income Tax Returns (Form 1040 including ALL Schedules). Wesleyan must receive this information before your financial aid request can be given consideration. If you have any questions regarding the applicability of this second PFS to your situation, please call the Financial Aid Office (ext. 2256).
6. A true copy of the student's 2025 Federal Income Tax Return (Form 1040 including ALL Schedules), if the student filed a return.

You will receive an email from SSS asking you to send them a copy or upload missing information or documents.

Note: Failure to complete these steps or to fully complete any of the forms listed in these steps may result in 1) your application being discarded or 2) the missing information being filled in by us so that it is a detriment to your case for financial aid. It is not the job of the financial aid office to track down missing or incomplete information.

The analysis of the PFS will be sent to us by SSS after SSS has received your completed PFS. From this and our own analysis of your overall financial situation, a determination will be made as to how much your family can contribute toward the cost of tuition.
