I. CALL TO ORDER

Mr. Michael Kearney 72 Mountain Road Seymour, CT: Wanted to ask the Board if we could set up a date to be determined for a meet and greet for the students and the American Legion. He also wanted to have the Legion and Historical Society as a place where students can contact them to do some community service. He also stated that the Legion sponsors the CT Hurricanes. The Hurricanes were charged over \$5,000 to use the facility at the Middle School that night. He is not sure where the numbers come from but with charges that high, there are no more funds left for the Veterans. He has heard the Hurricanes aren't going to have a Veterans appreciation concert next year due to the high cost.

Dr. Compton stated that we look forward to working with him and the organizations too. Regarding the cost, we can work together and see where all the cost is coming from. Custodial fee is what we charge, and there must be a Police charge as well. We will find out more behind that cost.

Annmarie Drugonis, First Selectwoman: 111 Middle Benham Road Seymour, CT: stated that if we are doing Shared Services, we want to have a meeting and discuss concerns and things out, and that there doesn't seem to have been any Facilities Committee meetings lately. She said it would be a good idea to put a town person on the committee as well. She stated that safety and our children are a priority.
