A complete meal is the best deal for your money! To be charged the complete meal price (instead of à la carte pricing) the student must take at least 3 out of the 5 items offered daily with one of those items being a fruit or vegetable choice. The five items offered daily are: Meat/Meat Alternative, Fruit, Vegetable, Bread/GRain and choice of Milk. If a student does not select items to equal a complete meal, they will be charged a la carte price for each item. Snack and Beverages are sold separately and do not count as a complete meal.
