District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. The School Safety Plan includes an overview of the school's current comprehensive safe school programs and initiatives as well as an annual action plan that addresses the four phases of an emergency planning: mitigation, preparedness, response and recovery. San Mateo County has implemented the Big Five School Emergency Guidelines. The plan identifies members of the school's emergency response team, their roles and responsibilities, and their lines of communications with the District's emergency response team. Emergency policies and procedures and the location and inventory of the school's first aid and emergency supplies kits are detailed. Each School Safety Plan incorporates the state's Standardized Emergency Management System and is aligned with the detailed District Emergency Management Handbook. Within the Emergency Management guidelines drills are practiced monthly for evacuation, shelter in place and duck and cover.
