School Facility Conditions and Planned Improvements

Skyline Elementary School was built in 1966. The school has 21 teaching stations (6 buildings, 3 portables, MUR, Library, Resource Center and Administration Offices) providing education for grades K-5. The District takes great effort to ensure that all schools are clean, safe and functional. All bathrooms, classrooms and offices are cleaned daily. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. The facilities work order process is used to ensure efficient service and that emergency repairs are given the highest priority. Our walking path around the perimeter of the grassy area on the recess yard was replaced in November 2019. In March of 2021, all classrooms were given air purifiers.

- Response to Intervention/ Student Study Team Process- we began to utilize a pre-referral system for early identification of students needing support. We enlist the knowledge of experts and strategize on how to best accelerate the growth of our students.

- Data Analysis- utilizing the PLC process and the Data Analysis Protocol, by grade level, as a staff, in order to better support student learning. We also offer other professional development opportunities as deemed necessary.
