While the Parkway Heights Middle School student community is comprised of diverse learners, our students have very similar needs and aspirations. We are also committed to providing a rigorous standards-based curriculum that will prepare all of our students for high school success. Student achievement data is used to place students in classes and on an on-going basis, to evaluate the overall effectiveness of our instructional program. Our English learners gain access to the core curriculum by receiving instruction that is tailored to meet their academic needs. Our Special Education students also receive instruction that is individualized and is intended to make the California Common Core Standards accessible to them. While the 2020-2021 started in 100% distance learning, due to the COVID-19 nationwide pandemic, our school community continues to function with all of the aforementioned programs in a virtual platform.

School Facility Conditions and Planned Improvements (Most Recent Year)

Parkway Middle School was built in 1953. The school has 41 teaching stations, MUR, Counseling Center, Locker Rooms and Administration Offices providing education for grades 6-8. The District takes great effort to ensure that all schools are clean, safe and functional. All bathrooms, classrooms and offices are cleaned daily. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. The facilities work order process is used to ensure efficient service and that emergency repairs are given the highest priority.

Architectural planning for replacing the entire school began during the 2013/2014 school year. Local bond funds were used. The new classrooms, library, and MUR were occupied by students in the 2019-2020 school year.

Parents and the community are very supportive of the educational programs at Parkway Heights Middle School. The Parent Teacher Student Association (PTSA) plays an active role at Parkway Heights Middle School through fundraising and the organization of special activities. PTSA meetings are held the third Wednesday of each month (see master school calendar for changes) at 6:00 p.m. This provides opportunities for parent input as well as information on current events and on the school program. Parents are also represented on the School Site Council (monthly meetings), and on the English Language Advisory Council (ELAC-4 meetings/year). Parents and community members are also represented on the Parkway Heights School Site Council; a team that monitors the implementation of our school improvement efforts. Meetings have been conducted virtually since March 2020 when distance learning began with parent/staff participation minimally impacted.

All teachers in the South San Francisco Unified School District have the opportunity to participate in formal, full-day professional development days scheduled as part of the district calendar.

Professional Development days in 2020-21 have/will focus on best teaching practices required to address district LCAP Goal priority 1 and the continued work of developing a guaranteed and viable curriculum for all students in ELA, Math, science and social science. Scope and Sequence meetings have been held the past 2 years in the major content areas to ensure a uniform pacing guide district-wide. Teachers administered a common formative assessment and reviewed student results in order to inform instruction. Another major area of professional development has been in what we refer to as unpacking priority standards. These standards are taught and assessed in the form of CFA's that are taken throughout the course of the school year. Data analysis consists of scoring, calibration, and analyzing the results of student performance on these assessments.
