Dear Parent or Guardian:

As you may be aware, on June 23, 2011, the Board of School Directors of the Lampeter-Strasburg School District adopted a Student Activity Fee policy as recommended by the District's Fiscal Responsibility Task Force. The charge of the Task Force was to review discretionary District programs and make recommendations pertaining to funding priorities and alternate funding streams for the discretionary programs. The approved policy initiates a Student Activity Fee as a condition for any high school student participating in an extracurricular activity or in interscholastic athletics.

Highlights of the policy include the following:

- As a condition of participating in an extracurricular activity or in interscholastic athletics, a high school student shall be required to pay a student activity fee. The activity fee shall be paid for the school year, shall be applied for the school year, and shall be applied only once per student without respect to the number of extracurricular activities and/or interscholastic athletics in which the student participates during that school year.
- Students participating in the National Honor Society, student government or as a class officer, shall not be required to pay an activity fee for that particular activity.
- Students participating in any extracurricular activity that does not have an advisor who is paid by the School District for that activity, shall not be required to pay an activity fee for that particular activity.
- The Superintendent may, in the exercise of his/her sole discretion, waive the Student Activity Fee for any student. Students who have qualified for and been approved by the School District for free or reduced lunch in the current school year are encouraged to apply to the Superintendent for a waiver of the Student Activity Fee.
- There shall be no refunds of any portion of the Student Activity Fee.
- The Student Activity Fee for students of the high school shall be as follows, but not to exceed \$150 per family per school year (or a maximum of \$50 per student per school year):
 - interscholastic athletic activity - \$50
 - extracurricular activity - \$35

The coach or advisor of each activity shall be responsible for collecting the Student Activity Fee. The principal of the building shall be responsible for maintaining records on the payment of the student activity fee by each student.

STUDENT ACTIVITY FEE REMITTANCE FORM

L-S Student/Parent/Guardian:

For the 2025-2026 school year, the Lampeter-Strasburg School Board continues to require the following extracurricular activity fees. For any students participating in an activity (a completed list of activity fees is shown on the reverse side) the fee will be \$50 for a sport and \$35 for a club. The maximum per student fee is \$50 while the maximum per family fee is \$150.

This form should be returned in a sealed envelope to the sponsor/coach. The student activity fee shall be paid prior to the student's participation in any element of the extracurricular activity or the interscholastic athletic activity. For the purpose of interscholastic athletic activities involving tryouts, the student activity fee will be due within three (3) calendar days of the team roster being submitted to the Athletic Director. Students who have qualified for and been approved by the School District for free or reduced lunch in the current school year are encouraged to apply to the Superintendent for a waiver of the Student Activity Fee. The activity fee is non-refundable.

Important Note:

Students may try out for sports teams before paying the fee. However, once they have been selected for the team or activity, the fee must be paid or the selection will be revoked. Paying the fee does not guarantee that a student will be selected for a team/activity or playing time, nor does it supersede academic requirements.
