RE: Approval of Children’s Center Summer Field Trips

BACKGROUND:

The School-Age Summer Program at the Children’s Center requests permission to participate in the following field trips for the summer: Oakland Zoo (June 6), Happy Hollow Park and Zoo (June 21) and Aquarium of the Bay (August 1).

FISCAL IMPLICATIONS

The cost of Oakland Zoo is \$15 per child, Happy Hollow Park and Zoo \$11:95 per child, and Aquarium of the Bay is \$14.14 per child. All costs will be covered by fund 12.

RECOMMENDATION

It is recommended that the South San Francisco Unified School Board of Trustees grant permission for the Children’s Center students to participate in these three summer field trips.
