We host curriculum nights to ensure they know about our core content and how to use the Tyler student information system to monitor their child's progress. Fall conferences are held for open feedback. CARE teams are conducted to assist parents understanding support for academics, IEPs, and 504s are hosted to assist parents with academic and behavioral support.
