### Involvement Process for the SPSA and Annual Review and Update

Parental involvement at Bailey Elementary is evident the moment you step onto our campus. The Muroc Joint Unified School District is committed to fostering a robust home-school partnership, offering various parent/community education and involvement programs to encourage meaningful collaboration with the community and parents. Bailey's administration actively provides parents with training opportunities, ranging from informational sessions to efforts aimed at enhancing parents' capacity to support their children's learning needs. Importantly, the Bailey staff is readily available

for parents to meet, plan, learn, and receive training on various topics, encouraging them to be positive contributors to the school community.

The Bailey Business Council (BBC) meets at least ten times a year. The BBC elects officers, updates the school profile, approves the site budget, reviews testing data, gathers feedback from parent surveys, reviews drafts of the upcoming Single Plan of Student Achievement (SPSA), evaluates school benchmark data, finalizes the SPSA, reviews the School Accountability Report Card (SARC), and finalizes needs surveys. The English Learner Advisory Council (ELAC) meets four times a year and provides input to the SPSA through formal surveys on issues discussed at meetings.

To support school programs and supplemental materials through fundraisers and volunteering, parents have organized the Bailey Business Council. This council takes charge of organizing and providing fundraisers, lunches, resources, and recruiting parent volunteers. The Bailey Business Council maintains a Calendar of Events detailing their activities and consistently provides direct resources to students, including field trips, classroom incentives, and other benefits. During each meeting, parents are encouraged to share suggestions for enhancing opportunities and types of parental involvement, with the overarching goal of ensuring parents feel welcomed and an integral part of the active learning community at Bailey. The school is steadfast in its commitment to creating an environment where parents are actively engaged and contribute positively to their children's educational journey.

## Resource Inequities

The William A. Bailey Elementary School has experienced an increase in chronic absenteeism among all student groups, including Hispanic, socioeconomically disadvantaged (SED), and students with disabilities (SWD). The California State Dashboard has marked chronic absenteeism in red, indicating a critical area of concern.

Despite this challenge, all students at Bailey Elementary have access to necessary instructional materials and technology. Each student has been provided with Chromebooks and other appropriate assistive technologies. Additionally, students receive manipulatives and notebooks to support their learning across all subjects. To further aid in their educational journey, students have access to books, schedules, and positive behavior tokens.

Communication between parents and teachers is maintained daily, ensuring a robust support system for students. For parents who request them, academic packets are available. Overall, students are equipped with all the instructional materials they need to succeed in the classroom.

Efforts are ongoing to address and reduce chronic absenteeism while maintaining a supportive and resource-rich learning environment for all students.



        - i. Help the school understand the subjects and skills for which teaching and learning need to be improved.
        - ii. Identify the specific academic needs of students and groups of students who are not yet achieving the State's academic standards.
        - iii. Assess the needs of the school relative to each of the components of the schoolwide program under §200.28.
        - iv. Develop the comprehensive needs assessment with the participation of individuals who will carry out the schoolwide program plan.
        - v. Document how it conducted the needs assessment, the results it obtained, and the conclusions it drew from those results.
    - B. Identification of the process for evaluating and monitoring the implementation of the SPSA and progress towards accomplishing the goals set forth in the SPSA (described in the Expected Annual Measurable Outcomes and Annual Review and Update).

## Requirements for the Plan

- II. The SPSA shall include the following:
  - A. Goals set to improve pupil outcomes, including addressing the needs of student groups as identified through the needs assessment.
  - B. Evidence-based strategies, actions, or services (described in Strategies and Activities)

1. A description of the strategies that the school will be implementing to address school needs, including a description of how such strategies will:
  - a. Provide opportunities for all children including each of the subgroups of students to meet the challenging state academic standards
  - b. Use methods and instructional strategies that:
    - i. Strengthen the academic program in the school,
    - ii. Increase the amount and quality of learning time, and
    - iii. Provide an enriched and accelerated curriculum, which may include programs, activities, and courses necessary to provide a well-rounded education.
  - c. Address the needs of all children in the school, but particularly the needs of those at risk of not meeting the challenging State academic standards, so that all students demonstrate at least proficiency on the State's academic standards through activities which may include:
    - i. Strategies to improve students' skills outside the academic subject areas;
    - ii. Preparation for and awareness of opportunities for postsecondary education and the workforce;
    - iii. Implementation of a schoolwide tiered model to prevent and address problem behavior;
    - iv. Professional development and other activities for teachers, paraprofessionals, and other school personnel to improve instruction and use of data; and
    - v. Strategies for assisting preschool children in the transition from early childhood education programs to local elementary school programs.
- C. Proposed expenditures, based on the projected resource allocation from the governing board or body of the LEA (may include funds allocated via the ConApp, federal funds, and any other state or local funds allocated to the school), to address the findings of the needs assessment consistent with the state priorities, including identifying resource inequities, which may include a review of the LEAs budgeting, it's LCAP, and school-level budgeting, if applicable (described in Proposed Expenditures and Budget Summary). Single school districts (SSDs) or charter schools that are eligible for CSI, TSI, or ATSI, shall develop a SPSA that addresses the applicable requirements above as a condition of receiving funds (*EC Section 64001[a]* as amended by Assembly Bill [AB] 716, effective January 1, 2019).

However, a SSD or a charter school may streamline the process by combining state and federal requirements into one document which may include the local control and accountability plan (LCAP) and all federal planning requirements, provided that the combined plan is able to demonstrate that the legal requirements for each of the plans is met (*EC Section 52062[a]* as amended by AB 716, effective January 1, 2019).

Planning requirements for single school districts and charter schools choosing to exercise this option are available in the LCAP Instructions.
