Food Services Update and Payment Options for the 2025-26 School Year

Payments Options: Families may pay for meals purchased in the cafeteria through MySchoolBucks account, cash or check deposited to your student's account.

MySchoolBucks

For your convenience, an easy online payment system is offered to fund and view your student's meal account at MySchoolBucks. Each family can create an account. Login and account information is available on the MySchoolBucks website. Please note there is a fixed service fee, per transaction, of \$3.50 associated with this service. This charge is not associated with Food Service department. MSB Family Pass

Checks

Please make checks out to Trumbull Food Services and include students district ID number. Teachers will collect these envelopes in the classroom and send them to the cafeteria staff daily.

• Middle School and High School students can give check(s) directly to the cafeteria staff marked with the student's name and District ID number.

Cash

Cash can be deposited in your students account in each school location. Please place in a sealed envelope clearly marked with the student's name and District ID number. Students should present the envelop to the cashier during meal service.
