Dear Ellicott Families,

We want to give some information about our lunch program for the school year 2025/26. We are fortunate to have free breakfast and free lunches for this school year. We still need you to go to the school website into the Ezmeal app Free and Reduce meal application. This will help our school get extra funds for our food program. If you have a Middle or High School student and qualify for free or reduced lunch you will have reduced Athletic Fees.

Every student receives one free breakfast and one free lunch per school day this year. There is no charge. Any seconds or extras must be paid with cash as students are not allowed to charge to their account this year. If you would like to put money on your students account for them to spend on extras, you may use the contact information below. Please keep in mind that if they don't have money in their account, they can't charge it. If they bring home lunch and just want to take the milk/chocolate milk they need to pay at that time or have money on the account. A charge is made when they only take the milk/chocolate milk of .50 cents. Ellicott Elementary and Middle school students are offered an afternoon snack with that being said we need parents to provide the snack for the first two weeks of school. The school will provide the afternoon snacks starting the 25th of August.

We accept cash, check, credit or debit cards at the office or call with your credit card information and we can process it over the phone. This can't be done with credit/debit during the lunch hour.
