Professional development activities are planned to ensure that proper training and support are provided relative to the new curriculum and support on adopted materials.</p>
<p>Years Two and Three Materials and Implementation</p>	<p>The purpose of Years Two and Three is:</p> <ol style="list-style-type: none"> 1. Implement the curriculum and identify professional learning needs. <ul style="list-style-type: none"> ● Develop common assessments based upon objectives, beginning with one common assessment for each quarter. ● Effective use of time in PLCs, effective use of data, and changing instructional strategies based on the learning issues identified by the common assessments. 2. Materials review and selection
