I. PURPOSE

This RFQ is intended to solicit proposals for the purpose of entering into a contract through competitive negotiations for the professional services of an Architect firm. The selected firm will contract directly with the Santa Maria ISD.

The Santa Maria ISD reserves the right to reject any or all proposals for just cause and to waive any informalities in the submission process if it is deemed to be in the best interest of the project.

II. BACKGROUND

The Santa Maria ISD began exploring options for improvements to the district's facilities. After a series of meetings, the administration arrived at a few potential projects. The Administration is now seeking to construct or do improvements to buildings in the district. The costs for projects will vary from 25K to 500K.

III. SCOPE OF WORK

This RFQ seeks design services for schematics, design development, and construction documents for final build-out of the project.

Respondents may meet with Administration who wish to participate in the RFQ process. The site visit can be arranged at the respondents' convenience by contacting the Maintenance Supervisor, Rey Sanchez, @956-565-6308.

This RFQ will employ a transparent, competitive public bid process, with the intention of identifying firms with the vision and experience to meet the goals of the project through thoughtful and efficient building design and materials.

We anticipate that the scope of work for the project may require meetings and presentations with the Santa Maria ISD School Board over the course of the contract. This may be inclusive of interviews. It is difficult to determine the exact number of such meetings.

The respondent agrees and acknowledges that the Scope of Work is an outline only and is not a complete, detailed or exhaustive description of each specific service that must be provided by the engineer.

The respondent agrees that any final Professional Services Agreement will require him or her to provide all services necessary to permit the complete design, development and construction of the project as required by the terms and conditions of any such final Professional Services Agreement, whether or not such services are expressly identified or described in this RFQ.

The respondent acknowledges that certain services identified and described below are to be performed together with other parties involved in the project, and the architect agrees to perform all such services, consistent with applicable standards of professional care, and to cooperate fully with all other parties involved in the project.

VI. SUBMITTAL REQUIREMENTS

Proposals should be prepared simply and economically, providing a straightforward and concise description of the respondent’s capabilities for satisfying the requirements of the RFQ. Emphasis should be on completeness and clarity of content.

The respondent’s proposal shall include:

- A. Cover letter.
- B. A brief history of the business/organization including the resumes of principals and key staff assigned to the project.
- C. A brief narrative describing the respondent’s design vision for the site and any unique design features.
- D. A description of respondent’s relevant work experience and qualifications to perform the work described above.
- E. A description of engineering services and coordination activities over the past five years, including location of work and name of client.
- F. A proposed schedule outlining milestone dates for schematics, design development documents, 50% construction documents, 100% documents, and submission to the Santa Maria ISD.
- G. Contact information for references from previous clients.
- H. Statement of proof of professional liability coverage for errors and omissions.

VII. EVALUATION CRITERIA

1. Expertise, experience, and qualifications of the respondent for providing the services described above. Personnel presented in the proposal are expected to be the same personnel as will be substantially involved throughout the life of the project.
2. A demonstrated track record of coordinating design professionals and consultants toward the successful design of similar projects.
3. Completeness of the submittal and compliance with the requirements of the RFQ.
4. Input from references.

VII. SELECTION PROCESS

The Santa Maria ISD will evaluate the applicants according to the identified criteria and will choose the provider on the basis of demonstrated competence and qualifications to perform the services for a fair and reasonable price. We reserve the right to interview a short-list of respondents, which shall not exceed three respondents. The selected engineer will be announced after careful consideration and verification.

Final selection will be contingent on fee and contract negotiations. If a satisfactory contract cannot be negotiated with the most highly qualified provider of engineering services, the Santa Maria ISD will formally end negotiations with that provider, select the next most highly qualified provider, and attempt to negotiate a contract with that provider at a fair and reasonable price.

VIII. GROUNDS FOR REJECTION

The Santa Maria ISD reserves the right to reject any firm for one or more of the following reasons:

- 1) Submission does not contain all information requested in the RFQ.
- 2) Submission not received by the required the deadline.
- 3) Firm does not possess the required minimum qualifications.

IX. TERMS & CONDITIONS

In submitting a response to this RFQ, applicant acknowledges that:

- 1) Applicant has read and understands all terms and conditions set forth in this RFQ.
- 2) The Santa Maria ISD reserves the right to revise any terms and/or conditions set forth in this RFQ and/or add any terms and/or conditions beyond those set forth in the RFQ.
- 3) The progress of this project is subject to further feasibility analysis. As such, Santa Maria ISD reserves the right to terminate this contract or place the project on hold indefinitely.
