Admission Requirements for the California State University (CSU)

Eligibility for admission to the CSU is determined by three factors: (1) Specific high school courses, (2) Grades in specified courses and test scores, and (3) Graduation from high school. Some campuses have higher standards for particular majors or students who live outside the local campus area. Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. Professional Development

Quality instruction and instructional leadership are at the heart of the district's achievement efforts. West County Mandarin School is strongly committed to providing an equitable program that meets the needs of ALL our students. To ensure this, the Curriculum and Instruction Department of the district engages teachers, administrators, and other personnel in ongoing professional development focused on teaching and learning. Training is provided to principals and other administrators to continuously develop their ability to provide strong instructional leadership and guide teaching and learning at school sites. The principals, in turn, provide support to teachers through staff development activities, opportunities for collaborative study and planning, and individual coaching based on ongoing classroom observations. Teachers and other staff are provided with both on and off-site professional development in all standards-based curriculum content areas. Beyond the content areas, professional development is provided in language development, Gifted and Talented Education (GATE), differentiated instruction, Restorative Justice, and educational technology. In addition, West County Mandarin School is an International Baccalaureate (IB) School and is authorized to teach the IB Primary Years Program to all students. West County Mandarin School is also now in candidacy to become an IB Middle Years Program School for grades 6 to 8. Teachers continuously undertake PD and training on the IB program. In addition, training is made available in classroom management and the

effective use of assessment data and teacher data teams for meeting the needs of all students. West County Mandarin School also provides specialized Mandarin language professional development and coaching to its teachers. In addition, West County Mandarin School collaborates with other U.S. Mandarin immersion schools in the Chinese Early Language and Immersion Network of the Asia Society in order to identify and share best practices for teaching and learning in K-8 Mandarin immersion programs. A primary goal of the professional development program of the district and West County Mandarin School is to ensure that all students are served in a nurturing school environment by skilled, highly qualified teachers and that teachers are supported by strong knowledgeable instructional leaders.
