2025-2026 PARENT/FAMILY ENGAGEMENT POLICY

PART I. GENERAL EXPECTATIONS

Challenge Early College High School agrees to implement the following statutory requirements:

Challenge Early College High School will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:

 - Send emails inviting parents to annual Title I meeting
 - Post date of meeting on our website and social media
5. Challenge Early College High School will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
- Call parents to invite them to annual open house meeting
 - Send emails inviting parents to annual open house meeting
 - Post date of meeting on our website and social media
6. Challenge Early College High School will provide each parent an individual student reports about the performance of their child on the State assessment in at least math, language arts and reading by:
- Sending the individualized student report home in the mail
7. Challenge Early College High School will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:
- Sending a notification letter home to the parents

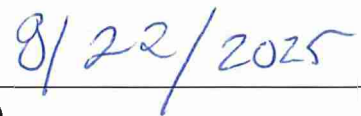
