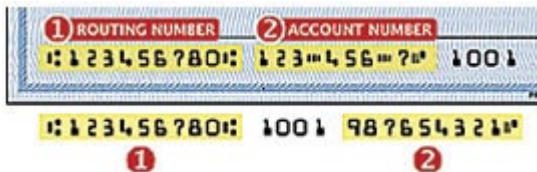
PINE PLAINS CSD SCHOOL TAXES can now be paid online by credit card or electronic check via MunicIPAY. Using this option is fast, easy and safe. Paying online also provides residents with instant proof of payment. A quick link to the online payment service www.infotaxonline.com is located on the homepage of the district website. To make online payments for multiple parcels, each parcel must be paid individually. Once your payment has been submitted, you will receive your confirmation number and digital receipt. A confirmation email with the same information will also be sent to the email address that you provide.

Credit Card Payments Made Online

The payment processing company charges a service fee of **2.65%** with a minimum charge of **\$3.00** to cardholders who use this service.

Electronic Check Payments

Payments will be charged to your checking or savings account at your bank. You will need your 9-digit routing number, as well as your savings or checking account number (see example below). A per transaction service fee of **\$1.50** will be charged by the payment processing company for this service.



IMPORTANT: To pay by Electronic Check, when Payment Options appear, click on the “Switch to Pay with Check” link and then continue entering your information.

PLEASE NOTE: Pine Plains CSD does not receive any income from the online service fee. Therefore, we cannot waive the fee.

FREQUENTLY ASKED QUESTIONS ABOUT YOUR TAX BILL

When is my payment due?

Tax bills are due by October 1, 2025 to avoid penalty. Bills paid from October 2, 2025 through November 1, 2025 must include a 2% penalty. Valid postmark dates will be accepted. Pitney Bowes, or similar metering system, is NOT a legal postmark. **PLEASE NOTE:** If the payment does not have a valid postmark on it, the payment date is the date it is received.

What information do I need to include with my payment?

- Your phone number needs to be included on your check.
- Remittance stub must be included with your payment. If a receipt is needed, return the entire bill.

What forms of payment do you accept?

- Checks made payable to School Tax Collector PPCSD
- Credit Card – VISA, MasterCard, American Express and Discover (**online only**)
- Cash – By Appointment ONLY. Please call 518-398-7181 ext 1234 to schedule an appointment.
- Money Order
- Electronic Check (**online only**)
