



HUDSON HIGH SCHOOL Dance Social Contract for Hudson Student

Hudson High School students are permitted to bring **ONE** non-Hudson guest to certain school dances. Guests of Hudson High School students must be **under** the age of 21. Middle School students **are not** permitted to attend High School Dances.

All Hudson High School students who are taking a non-Hudson student (defined as currently not enrolled at Hudson) to any school dance **are responsible for ensuring that their non-Hudson date follows all school rules and procedures pertaining to conduct at Hudson extra-curricular activities.**

Any non-Hudson date that violates Hudson High School extra-curricular rules and procedures will be asked to leave the dance immediately, **without refund**. **In addition, appropriate measures may be applied to any non-Hudson High School student whose conduct is found to be in violation of any school rules and procedures.**
