Student Parking Regulations

It is a privilege to drive a motor vehicle to Skyline High School and as such certain expectations and responsibilities are to be followed by each student driver while on campus, or on their way to and from campus. The Issaquah School District provides bus transportation, which students are encouraged to use. Parking in Skyline Student Parking lot is a privilege, NOT a right. All students must first purchase an ASB card to be eligible for student parking. The cost of a parking permit is \$70 per semester. All students parking on campus are limited to one parking space per household, except with senior standing. Parking permits may, NOT be re-sold or gifted to any other student.

Expectations for Driving On & About Campus

For those who drive to school, the following policies are necessary in order to fulfill fire regulations, assure parking spaces for visitors and for faculty whose assignments take them off campus during the day, maintain unobstructed bus lanes and to provide safety for all. Student may NOT park in following areas: Visitor and Faculty spaces; the bus loading zones/fire lanes or any yellow zone; along driveways in the parking lot, along curbs or designed handicap spots unless the student has a special permit issued by the State of Washington. Entrance, exit and directional markings are to be followed. The speed limit on campus is **10 M.P.H.** Students are required to follow all Washington State traffic laws: failure to do so will result in denial of the privilege of bringing a vehicle on campus. **Student may NOT loiter nor sit in cars to socialize at any time while on campus.** School officials will not assist student in gaining access to their vehicle or in its maintenance. At the end of the school day, student must wait for all buses to exit first. Reckless or irresponsible driving, speeding or endangerment either on campus or on the adjacent streets, before, during or after school can result in discipline, tickets and/or citations by the King County Police/Sammamish PD. Violations may result in school discipline, including but NOT limited to loss of parking privileges.

Parking Permit Procedures

Parking is limited (381 student spaces) at SHS. The adjacent county and residential streets are all posted "**NO PARKING**". Parking permits are only sold to students with a valid ASB cards as followed: Purchasing a parking requires the aforementioned ASB card, a valid driver's license, car registration, and proof of insurance and signed permission form signed by the student and legal guardian. Student Parking Permits cost \$70 per semester & \$140 for the annual permit. **Students may NOT resell, gift or provide their permit to any other student.** Parking permits grant students the privilege to park on campus during the school day in the student lot (parking spaces painted in white), but does NOT provide an assigned spot. Parking in the student lot is first come; first serve for those who have parking privileges. Students must register all vehicles that maybe/are driven to school, if students obtain another car during the semester, they must notify parking security so that the appropriate documentation can be changed or added. The parking permit **MUST BE CLEARLY DISPLAYED IN THE WINDSHEILD** of the vehicle; if it is not clearly visible, a violation **WILL** be written regardless of its registered status. Lost permits may be replaced at the cost of \$10.00. Priority parking will be given to seniors. IF any spots remain, they will be assigned, based on a lottery, to qualified juniors. Freshman and Sophomores are NOT eligible for parking privileges. No parking spots will be held for students outside of Skyline's attendance area or for those that register late for school. If you are a junior and violate any parking agreements at neighborhood lots, you will ineligible for the parking lottery. There will be severe consequences, such as but not limited to ticketing, towing at the owners expense, and/or loss of parking privileges, for students found in violation of the rules set by the ASB. **NO REFUNDS WILL BE GIVEN.**

Parking Violations

All students are expected to park and lock your vehicle in the designed areas of the student lot without blocking other vehicles. Illegal or inappropriate parking or parking without a permit is subject to fine, school discipline, towing, and/or loss of parking privileges. **THIS DOCUMENT IS CONSIDERED YOUR FIRST WARNING; NO SUBSEQUENT WARNING WILL BE GIVEN.**

Consequences of Parking Violations:

- 1. \$25.00 FINE
 - 2. \$50.00 FINE

 - 3. \$100.00 FINE
 - 4. Vehicle towed at owners expense
- In addition, parking privileges revokes.

*** Reproducing parking passes will result in in student discipline and immediate loss of parking privileges for the remainder of the school year or for subsequent school year/years. ***

Parking Violations Include:

- 1. Parking in Visitor and Staff spots (spaces painted YELLOW)
- 2. Parking in spaces not marked as a parking
- 3. Parking in a BUS or FIRE lane.
- 4. Parking in front of the school in the load/unload area.
- 5. Driving a non-registered vehicle onto campus.
- 6. Parking on sidewalks, flowerbeds, in non-student parking stalls or along any curb.
- 7. Any vehicle blocking any entrances or exits, gates or fire lanes WILL be towed at the owners expense.
- 8. Parking in the wrong direction in one way lanes.

Security Expectations

Exterior Doors ... By signing this document, **I agree to NOT prop exterior doors to the building or let people into the building through exterior doors.** Propping or opening doors to the building creates an unsecure location. I understand that if caught doing unsafe acts, it could result in the loss of parking privileges. I will enter through the main commons when enter the building.

Lock your vehicle while parking on campus and do **NOT LEAVE VALUABLES in your car.** Neither Skyline High School nor the I.S.D. assume any responsibility for lost or stolen items, or damage to the vehicle. All thefts, accidents, vandalism need to be reported for investigation to campus security immediately.

Issaquah School District Policy #3230: Vehicles parked on campus may be searched if suspected of containing illegal substances or stolen items. If students desire parking privileges, they agree not to allow contraband in their vehicles. Students agree that their vehicles are subject to search by school officials, if the officials develop individualized suspicion that the student/students are or have been violating a law or student conduct rule. Student s and their families understand the parking lots will be subject to periodic patrols by drug sniffing dogs at times when the students are not in the vicinity of the dogs. Students agree that if a drug sniffing police dog "hits" on their vehicle while it is parked on the school premises, school officials will have the authority to search the vehicle. If a student refuses to allow the search of any vehicles by school officials in such circumstances, students will lose their parking privileges and must understand that the I.S.D. will presume that the dogs have accurately discovered contraband in determining whether student disciplinary action is warranted.

Additional parking regulations may be added throughout the year to provide safety, security and appropriate operation of the school parking lot. I agree to follow these new regulations when they go into effect.
