## HOW TO MAKE A TAX CREDIT CONTRIBUTION

### If you are a current GPS parent with an Infinite Campus account:

Please access your online parent portal account which has options specific to your student's school and activities. You will need your Infinite Campus credentials to use this portal.

### If you are a community member making a contribution:

Please visit [www.gilbertschools.net/taxcredit](http://www.gilbertschools.net/taxcredit). This portal will offer options for all GPS schools and programs. This is not specific to individual students, but you will have the opportunity to note a student name if desired.

### Submit your payment by mail:

If you prefer to mail your contribution, you can print the Tax Credit Contribution Form available at [www.gilbertschools.net/taxcredit](http://www.gilbertschools.net/taxcredit) and mail your contribution and completed form to:

Under Arizona law, a state tax credit is available for contributions to support extracurricular activities in public schools. Generally, any optional, non-credit, educational activity that supplements the educational program of the school is considered to be extracurricular and eligible for tax credit funding. Senior trips and events that are recreational, for amusement, or tourist activities are not eligible.

You can:

- Make a contribution to the program of your choice
- Contribute to the named school of your choice
- Support your student's specific extracurricular activities
