## SCHOLARSHIP INFORMATION – 2025-2026

The Amesbury Public Schools offers fee-based transportation, athletics and co-curricular activity programs. The transportation fee is \$250/rider, family cap of \$500 for those students who live less than 2 miles away from school in grades K-6 and for all students in grades 7 – 12. Athletic user fees are \$350 per student per season with a family cap of \$1,000. Co-curricular activities are \$50 per student per year.

However, if your household income falls within the guidelines (shown below), you child may participate in any and all of the listed programs at no cost to you.
