Also in attendance were Superintendent Mr. Daniel Street, Bookkeeper Brooke Westcott, Elementary Principal Tyna Morrison, SpEd Director Nicole Kelly, Athletic Director Angie Stone, and Elementary educators Traci Heussner, Erika Swindler, and Katy Rogers.
