WHEREAS in 2024, he received the inaugural Lifetime Achievement Award from the New Jersey Basketball Coaches Association, further establishing his legacy in the sport;

NOW THEREFORE BE IT RESOLVED that the Board of Education extends its heartfelt congratulations to Jeff for his remarkable achievements and contributions to high school basketball and recognizes his exemplary dedication to fostering athletic excellence within our community.

Mr. Weaver recalled an impactful meeting with Mr. Jasper many years ago. He said his Park Ridge team was very good but they had some injuries to starters on the team when they played Paramus Catholic. They lost badly and after the game Coach Jasper gave Mr. Weaver a program

with a note on it and it is prominently displayed on a bookshelf in his office. He sees it everyday. Mr. Weaver also mentioned that when he attends Girls PV games, he goes to see Lois Jasper. He said she is the first person he sees sitting on her cushion seat and he greets her. He commented that behind a great man is an even greater woman. He indicated that the two of them are Pascack Valley Girls Basketball.

VI. COMMENTS FROM THE PUBLIC

Citizens are invited to make comments regarding agenda items and are limited to three minutes, according to the Pascack Valley Regional High School District Board of Education policy number 0167. Persons wishing to speak must, upon being recognized, rise, sign in and state their name, town of residence, and which agenda item(s) they are referencing.

Sadria Feratovic of Hillsdale, a junior at Pascack Valley said two of the best coaches he had are Len Cusumano and Bill Weigel. He mentioned that Coach Weigel is a mentor who taught him about football and life. He indicated that the team has been very successful the last two years with Coach Weigel. He commented about his character that the coach is a nice guy offering advice and easy to talk to. He is a great role model. He indicated that Coach Weigel has influenced both him and his brother. He commented that it's important to have a coach in the school so the person can help during the school day.

This creates a strong relationship between the coach and players. He believes that Coach Weigel should follow Coach Cusumano who succeeded Coach Nielsen as head coach. He mentioned that there is no disrespect for anyone who applied for the position but he would like to see Coach Weigel named head coach.

Mike Smith of River Vale said he is a third generation Teamster and a big union believer. He suggested that the Board consider insight not only from players but from parents on who will coach their kids. He commented that as a coach for the youth program he understands the time commitment and that the high school coaches devote even a greater amount of time. He said there is no disrespect to the coach being recommended. He acknowledged that Coach Weigel goes above and beyond as well as Coach Cusumano whose team won the championship. He respects the process that the Board follows. He reiterated that perhaps the Board will consider involving the parents and students in certain decisions. He wished they could continue on what has been built. Allison Weigel of Hanover and wife of Bill Weigel related a tale of two towns - Scotch Plains where she is a teacher and Whippany Park where she resides. She indicated that the two towns have football programs that have struggled. She mentioned that in the last 10 years Scotch Plains has had five head coaches and only one was a teacher in the building. She said that during the 10 years, the teams won 26 games and lost 71 with no playoff appearances. She commented that in her town the football program over the last 10 years had three head coaches and only one was a teacher in the building. The program won 32 games and lost 61 games with no playoff appearances. She indicated that PV has had only two head coaches in the past 25 years and both were teachers at the school. She mentioned that they appeared in seven sectional state playoffs, including three wins and countless number of playoff appearances. She said having the head coach in the building matters as it builds consistency, trust, accountability, and culture. She indicated that the coach is part of the school and players can check in with the coach. She said losing programs drain administrators, teachers, parents and the community. She made a comparison of Ted Lasso versus Bill Belichick if wins are desired. She indicated that people hate to lose and those who are accustomed to winning hate to lose even more. She commented that being part of a stable, successful and respected program, the Board should do everything in their power to protect it. She commented that what looked like a successful run to a championship is now a question mark. She implored the Board to hire the most qualified candidate who is also in the building to become the head coach. Jason Fouche of Hillsdale, an upcoming senior, mentioned that Coach Weigel and Press taught him discipline, confidence and how to be a leader. He said he took up football late and he was timid and scared. He was able to overcome the fear due to the coaches. He commented that his father was absent in his life and the coaches are a father figure to him. He indicated that the coaches work hard and they've made Pascack Valley a brotherhood.
