Plan Summary [2020-21]

General Information

A description of the LEA, its schools, and its students.

San Pasqual Union School reflects all that is good in San Diego's past, present, and future. Having recently celebrated our 100-year anniversary, we are reminded to honor our rich past while embracing a future of limitless opportunity. Originating from a two-room schoolhouse in the heart of Escondido's San Pasqual Valley and growing into our current 27-acre campus, San Pasqual Union School provides a quaint and inviting backdrop for inspired teaching and learning. The modern facilities include 29 classrooms with a dedicated art room, two science labs, an 18,000-book library, and the towering red "Barn" which serves as a gymnasium, theater, and multipurpose room. The District's boardroom, affectionately known as Trussell Hall, is a replica of the original schoolhouse and bears the name of Jane Trussell,

one of our founding educators. Additionally, the grounds of San Pasqual Union, including 18 acres of athletic fields, playgrounds, and gardens, are impeccably maintained to provide ample opportunities for outdoor learning and play.

The District employs _____ team members to support the academic, behavioral, and social/emotional growth of our transitional kindergarten through 8th-grade children. The demographics of our 584 students reflect our community's diversity with approximately 60% White, 27% Hispanic, and 13% of students of other or mixed races. Additionally, over 10% of our students are English Learners while 8% of our students are served through our Special Education program. 24.3% of our students are designated Socioeconomically Disadvantaged and receive supports through our free and reduced lunch program. Foster Youth make up 2.2% of our student population.

Teachers at San Pasqual Union School work collaboratively to prepare engaging lessons and utilize student data to drive instruction. Core academic programs are enriched via elementary rotations like music and STEM, while middle school exploratory wheels that focus on the arts, world languages/ communication, and technology. Despite the distinction of being the lowest funded district in San Diego County in per-pupil funding, San Pasqual Union maintains a rigorous academic program in which students consistently perform above state and county averages. As reflected on the 2019 California Dashboard, San Pasqual Union School was one of only 5 districts in San Diego County to maintain green and blue rankings in all major California Dashboard categories.

Student experiences are enhanced through strong partnerships with our families and the community. Volunteer groups such as the Parent Teacher Organization (PTO), SP School Foundation, Red Barn Arts, SAGE garden, School Site Council (SSC), and our District English Language Advisory Committee (DELAC) volunteer time, raise needed funds, and sponsor school events to enrich the learning experiences for all our children. Further, our community partnerships, including those with the San Diego Zoo Safari Park and California State University-San Marcos, provide unique opportunities for applied and "real world" learning experiences.

All of our San Pasqual "Saints" are encouraged to S.O.A.R., demonstrating that they are Safe, On-task, Accepting, and Respectful/Responsible in words and deeds. To that end, we promote students of character through the six core pillars of trustworthiness, respect, responsibility, fairness, caring, and citizenship. These pillars promote an overarching mission to ensure all children receive an education that builds the character, confidence, knowledge, and skills to prepare them to be competent life-long learners who can achieve excellence.

Reflections: Successes

2019 English Language Arts CAASPP scores reflect a 19.3 point improvement, resulting in a change from "green" to "blue" on the California Dashboard. Further, while white students increased 12.9 points in English Language Arts, subgroups increased as follows: English Learners +19.2 points, Reclassified English Learners +24.4 points; Students with Disabilities +19.6 points, Hispanic students +30.7 points,

Socioeconomically Disadvantaged students +34.9 points. Further, as per the California Dashboard, 64% of English Learners are making progress toward English language proficiency. It should be noted that progress between 55%-65% is designated as "High" progress levels.

2019 Mathematics CAASPP scores also showed dramatic improvements. Overall, students improved 10.5 points, resulting in a change from "yellow" to "green" on the CA Dashboard. Further, while white students increased by 3 points in mathematics, subgroups increased as follows: English Learners +21.4 points, Reclassified English Learners +32 points; Students with Disabilities +26.9 points, Hispanic students +22.8 points, Socioeconomically Disadvantaged students +28.6 points.

Chronic Absenteeism (the percentage of students missing 10% or more of school) remained low at 1.2%, down 1/5% from the previous year and earning a "blue" designation on the Dashboard. Similarly, suspension rates (the number of students suspended at least once during the school year) were also low (1.5%), down 0.5% from the previous year and garnering a "green" Dashboard indicator. The District also met standards for all local indicators, including Basics: Teachers, Instructional Materials Facilities; Parent and Family Engagement; and Local Climate Survey.

Reflections: Identified Need

While significant progress was made toward closing performance gaps, gaps still remain.

2019 English Language Arts CAASPP scores reflect that all students in the district, on average, scored 31.3 above standard. White, Two or More Races, and Hispanic students scored above standard, with scores of +47.6, +36.5, and +2.9, respectively. Other statistically significant subgroups performed below standard as indicated: Homeless (-9.1); English Learners (-19.1); Students with Disabilities (-60.4); and Socioeconomically Disadvantaged (-4.4).

2019 Mathematics CAASPP scores followed a similar pattern. When considering all students, the district scored 7.9 points above standard. White and Two or More Races scored above standard, with scores of +18.4 and +34, respectively. Other statistically significant subgroups performed below standard as indicated: Hispanic (-15.8); Homeless (-16); English Learners (-27.6); Students with Disabilities (-66.8); and Socioeconomically Disadvantaged (-22).

Less disparity is observed in Chronic Absenteeism. With the exception of Homeless students who scored in the "yellow" on the Dashboard, all other subgroups scored in the "green" or "blue" range.

However, disparities were observed in Suspension Rates as follows: English Learners and Homeless ("blue"); Hispanic and White ("green"); Socioeconomically Disadvantaged ("yellow"); Two or More Races ("orange"); and Foster Youth and Students with Disabilities ("red").

The District will continue efforts to support all students by implementing a program focused on Multitiered Systems of Support (MTSS).

A summary of the feedback provided by specific stakeholder groups.

Throughout the stakeholder engagement process, all groups (staff, parents, committees, School Board, etc.) emphasized the importance of student safety and well-being as a top priority.

Parents emphasized the need to support the social/emotional needs of students and stressed the importance of parent/community engagement through activities and events. DELAC parents highlighted the need to continue programs and supports that have led to success for English Learners, while School Site Council focused on providing programs to meet the needs of advanced students. Parents reported being most satisfied with school safety, parent engagement, and the quality of leadership. They reported being least satisfied with current social/emotional supports provides for students and the communication from middle school teachers.

Teachers tended to prioritize support for at-risk students. They also stressed the need for more collaborative time with one another and noted the importance of using data to inform teaching and learning. Teachers reported being most satisfied with school safety and the quality of leadership. They reported lower levels of satisfaction with professional development and the availability of instructional resources. Both parents and teachers are pleased with the recent improvement in academic performance and emphasized the need to build upon those gains. They both highlighted the writing program as a curricular area in need of improvement.

Students generally feel safe and supported at school. They are generally satisfied with the quality of their education (80%), but the levels of satisfaction, including satisfaction with access to academic and emotional supports, tend to drop as students matriculate through grade levels.

All three overarching goals within the LCAP have been directly influenced by stakeholder input.

Consistent with input received by staff, parents, and students, LCAP Goal 1 will focus on Academic Achievement for Every Student. Actions will work toward improving instructional effectiveness and expanding curricular offerings. To this end, action steps will focus on the use of data to promote teaching and learning. Through these initiatives, students below, at, and above grade-level standards will be appropriately supported and challenged.

Similarly, LCAP Goal 2 will address the top priority of stakeholders, a Safe, Clean, and Well-Maintained School Facility and Campus. In addition to action steps designed to promote student safety, a five-year commitment through the School Climate Transformation Grant (SCTG) will promote student wellbeing via the Multi-Tiered Systems of Support (MTSS) model.

Finally, stakeholders value and students benefit from the acquisition and cultivation of Family and Community Partners in Education. LCAP Goal 3 will seek to maintain and grow these connections with the goal of creating more academically enriched and aligned learning opportunities.

Introduction and Instructions

In order to address this condition of our low-income students, we will develop and implement a new attendance program that is designed to address some of the major causes of absenteeism, including lack of reliable transportation and food, as well as a school climate that does not emphasize the importance of attendance. Goal N, Actions X, Y, and Z provide additional transportation and nutritional resources as well as a districtwide educational campaign on the benefits of high attendance rates. (Contributing Action(s))

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100% attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])

COEs and Charter Schools: Describe how actions included as contributing to meeting the increased or improved services requirement on an LEA-wide basis are principally directed to and effective in meeting its goals for unduplicated pupils in the state and any local priorities as described above.
