

# Student Device User Agreement

The East Islip UFSD is providing a computer device to all Grade K-12 students and when received, should be the only device students utilize when connecting to digital learning.

The goals of the student device program include:

- Providing equity to all students through common technological device access.
- Facilitating students' confidence and proficiency in using technology as a tool to enhance learning.
- Promoting opportunities for students to demonstrate the ethics and etiquette necessary with technology use.
- Offering access to all information anytime, anywhere.
- Extending learning opportunities beyond the school day.

Students utilizing the device must follow these East Islip UFSD policies:

- Policy #4526: Computer Network and Internet Access Acceptable Use
- Policy #4527: Acceptable Use – Remote Learning

(District policies can be found on the Board of Education page of the East Islip Union Free School District website.)

This agreement is made effective upon receipt of a student device between The East Islip Union Free School District ("EIUFSD"), the student receiving a device ("Student"), and his/her parent(s) or legal guardian ("Parent"). The Student and Parent(s), in consideration of being provided with a 1:1 device, including power adapter, case and software ("accessories") for use while a student at EIUFSD, hereby agree as follows:

## 1. Equipment

- 1.1. Ownership: EIUFSD retains sole right of possession of the 1:1 device and grants permission to the student to use the 1:1 device according to the guidelines set forth in this document and in conjunction with the EIUFSD Computer Network and Internet Access Acceptable Use Policy (#4526) and the East Islip UFSD Responsible (Acceptable) Use of Technology guidelines. EIUFSD will retain records of the serial numbers of provided equipment. EIUFSD retains the right to collect and/or inspect the 1:1 device and accessories at any time, including via electronic remote access; and to alter, add, erase, or delete installed software (including the device OS), customizations, or hardware.
- 1.2. Substitution of Equipment: In the event the 1:1 device is inoperable, EIUFSD has a limited number of spares for use while the 1:1 device is repaired or replaced. This agreement remains in effect for such a substitute. The student may NOT opt to keep a 1:1 device or to avoid using the 1:1 device due to loss or damage.
- 1.3. Configuration and Software: Efforts are made to keep all 1:1 device configuration the same. All systems include ample RAM, applications, and wireless network capability. The student may not install any software which violates the EIUFSD Computer Network and Internet Access Acceptable Use Policy (#4526) and the East Islip UFSD Responsible (Acceptable) Use of Technology guidelines. Uninstalling

any school provided or OS software or profiles from the 1:1 device is not permitted. Operating System and Application updates will be run from a central location. Failure to comply will result in disciplinary action.

- 1.4. Optional Insurance: Device insurance is available for parents to purchase through the district for \$40 per device (purchased through MySchoolBucks or checks made payable to East Islip UFSD). Insurance should be purchased within 30 days of receiving a device or 30 days into the start of the new school year. Refer to Device Protection Plan Information.
- 1.5. Return of equipment: At the end of each school year students may be required to return the 1:1 device and all accessories to the school. EIUFSD will charge the Student and Parent for any items not returned. Any items that are damaged will be charged to the Student or Parent as well. Students who leave EIUFSD during the school year must return the 1:1 device and all accessories at the time they are signed out of school.
- 1.6. Technical Support and Repair: EIUFSD will provide technical support, maintenance, and repair during school hours. Any attempt to repair outside of EIUFSD may result in the Student and Parent being charged the full replacement cost of the device or accessories.

## **2. Legal and Ethical Use Policies**

- 2.1. Monitoring: EIUFSD will monitor 1:1 device use using a variety of methods to ensure compliance with all applicable policies and this agreement. Any attempt to “jailbreak” the device or remove the EIUFSD profiles will result in disciplinary action.
- 2.2. Legal and Ethical Use: All aspects of EIUFSD Computer Network and Internet Access Acceptable Use Policy (#4526) and the East Islip UFSD Responsible (Acceptable) Use of Technology guidelines remain in effect during the use of the 1:1 device. EIUFSD will make every attempt to provide content filtering within the EIUFSD network and outside the network. However, EIUFSD does not have full control of the information on the Internet or incoming email while off campus.
3. File-sharing and Proxy Apps/websites: The installation and/or use of any Internet-based file-sharing tools or Proxy Apps/websites designed to circumvent filtering software are explicitly prohibited. File sharing programs and protocols may not be used to facilitate the illegal sharing of copyrighted material (music, video, and images).
