Dear Pine Plains Families,

We are proud to share that for the 2025–2026 school year, all students in all Pine Plains schools will continue to receive breakfast and lunch at no cost, thanks to the District’s ongoing participation in the Community Eligibility Provision (CEP). This program ensures that every student has access to one free breakfast and one free lunch each day school is in session, regardless of family income. No application is required to receive these meals.

Meal Pricing for Additional Purchases

While one breakfast and one lunch are provided daily at no charge, additional meals may be purchased at the following rates:

- Breakfast: \$1.75 (all schools)
- Lunch: \$2.75 (Cold Spring Early Learning Center and Seymour Smith)
- Lunch: \$3.00 (Stissing Mountain Junior/Senior High School)

À la carte items, such as snacks, bottled water, extra entrées, and other individual items, are not covered by CEP and are available for purchase separately. Any outstanding meal debt incurred before the start of the program will remain the responsibility of the family.

Even though meals are free for all, we encourage all families to complete the annual income verification form, available on our website or from your school’s main office. Completing this form helps the District secure important funding and may also qualify your family for additional benefits, including:

- Reduced-cost internet
- Academic testing fee waivers
- College application discounts
- Other community-based services
