I understand that if my participation in the College course appears to have a negative effect on my high school achievement, I may consult with the BC3 Assistant Director of High School Programs and high school guidance counselor, or home school evaluator for academic advising.

I understand that upon completion of my coursework, it is my responsibility to request my transcript to be sent to the college I plan to attend.

I understand that the college I plan to attend makes the final determination on the credits they will accept via transfer. Assistance with this process can be directed to the Assistant Director of High School Programming or the Records and Registration Office.
