

Alcohol & Other drugs (AOD) Policies: The following information provides a general guideline for school personnel to follow when there is a concern raised by a student with regard to use, possession or distribution of drugs or controlled substances. The ACPS Alcohol and Other drugs (AOD) abuse regulations guidelines mandates that students shall not possess, use, and/or distribute alcohol, tobacco and/or tobacco products, or other drugs on school property, on school buses, or during school activities, on or off school property. What AOD related Illegal behaviors ?

- Use and attempt to use
- Possess and attempt to possess
- Procure or attempt to procure
- Purchase or attempt to purchase
- Distribute or attempt to distribute
- Solicitation or attempt to solicit

What substances ?

Code of conduct: “Students shall not manufacture, give, sell, distribute or possess with intent to give, sell or distribute marijuana, synthetic cannabinoids, or other controlled substance as defined in the [Drug Control Act, Chapter 34 of Title 54 of the Code of Virginia.](#)”
JFCF-R/JFCI-R: “...Include alcohol, marijuana, narcotic drugs, tobacco or tobacco products, hallucinogens, stimulants, depressants, and anything else covered by the Drug Control Act, as well as any volatile/ignitable inhalant materials and/or aerosols, e-cigarettes (including electronic or non-electronic devices/tools/materials used for vaping and ‘juuling’), anabolic steroids, look-alike drugs, drug paraphernalia, both prescription and non-prescription/non-controlled drugs if they are not taken in accordance with Policy [JHCD](#) and Regulation [JHCD-R](#), and anything that a student represents to be a restricted substance or that a student believes is a restricted substance”

How can I identify a student at risk?: A student may self-disclose any form of illegal substance use—whether in writing assignments, drawings, or through direct or indirect verbal statements. Additionally, a student may be subject to disciplinary action if they are caught in the act of possessing, distributing, or using illegal substances. If a student self-discloses illegal substance use in any form, it should always be taken seriously. Any expression of thoughts or behaviors related to the use or possession of illegal drugs should be immediately referred to a Qualified School Professional (QSP) for intervention. Parents need to be informed about the matter. **Qualified School Professional (QSP) include :** School administrator, assistant principal, school social worker, school counselor, nurse, mental health specialist, or the substance abuse counselor.

USE: Policy [JFC](#): Student Code of Conduct: prohibits students from being under the influence of prohibited substances at school

Student Safety is the Priority: Immediately move the student to a safe, supervised location. A staff member must stay with them at all times.
Notify Key Personnel: alert a school administrator and the school nurse immediately
Consult the Nurse (SN) : The nurse will assess the student’s condition to determine the appropriate level of medical care.
Decision: The administrator and Nurse will then decide and coordinate the next steps for medical care, including whether to dismiss the student to parents or call emergency medical services (EMS.)
Inform Parents: the administration will contact the student’s parents or guardians to inform them of the situation.
Note: If no EMS is required but signs of impairment indicate needs for medical care, the administrator arrange for the student to be picked up by the legal guardian. They should also be advised to seek medical care for their child.
Document the Incident: all observations and actions taken must be documented
Involve School Resources: Based on possible findings the Principal consult/report to Sch. Resource Officer (SRO).Policy [KNAJ title IV, CLA](#) “immediately reports to the local law-enforcement agency any incident described in clause 85 III.A.1 (alcohol, and other drugs) according to Policy [KNAJ](#) that may constitute a felony offense”
Refer the case: to the Substance Abuse Counselors (SA) team: Using the [Referral From](#)
Follow Up: The school administrator will advise student support team (SST) members to follow up with the student and family after the incident.
SA counselors: will provide follow up, services and support as outlined in the [JFCF-R/JFCI-R](#), regulations
Consequences: The school administrator will determine the appropriate consequences based on **Policy [JFC](#): Student Code of Conduct, which prohibits students from being under the influence of prohibited substances at school.**

Possession and/or Distribution

- If a student is in [possession or distribution: \[KNAJ title IV, CLA\]\(#\); \[JFCF-R/JFCI-R\]\(#\).](#)
- Report to the administrator: The administrator decide next steps to include:
 - The administrator report/consult to the police/school SRO
 - The incident is documented
 - The school administrator will determine the appropriate consequences based on Policy
 - The case is referred to the Disciplinary Panel
 - The parents are informed
