



Renewal of Community School Sponsorship Contract Timeline, Extended Response, and Rubric

Contract Expiring June 30, 2026

Any community school seeking renewal of a sponsorship contract must submit a complete renewal application.

Timeline:

- High Stakes Review Completed by Sponsor by September 19
- Renewal Applications are due by October 17 of the calendar year before renewal
- Sponsor Renewal Application review period from October 17 until January 15
- School and Sponsor review and discussion of renewal results and notice of decision issued to schools by January 15
- If approved, renewal of contract negotiated and executed by both boards on or before June 30

The High Stakes Review comprises 70% of the total renewal application score. The answers and documentation provided in the Extended Response(below) are also scored and are worth 30% of the total renewal application score. Together, the High Stakes Review and the Extended Response submissions provide the basis for decision-making on the renewal process.

Please provide thorough responses to all questions in this application. You are encouraged to include any supplementary information or documentation that you deem supportive of your answers or pertinent to the Sponsor's decision-making process regarding renewal.

The Extended Response portion of the application is a component in the renewal process and is in addition to the High Stakes Review scoring. **You must complete this entire application to qualify for renewal.** Responses within section A-E will be evaluated according to the criteria outlined in the attached rubric. In section F, the applicant may provide the sponsor with additional evidence to consider as a part of the Renewal Application.
