



Actual revenue for the month was up **\$3,534,166** compared to last year.



Revenue through August totaled \$52,031,605, which is \$1,610,242 or 3.2% higher than the amount collected last year. Through August, the largest categorical variances when compared to last year, are: real estate taxes higher by \$979,640 (due to collection in the Spring being less than expected), and public utility per. prop. tax higher by \$759,373.



Actual expenses for the month were up \$178,919 compared to last year. Categories with the largest variance included: higher transfers out of \$1,000,000, and higher professional and technical services of \$367,120. A single month's results can be skewed compared to a prior year because of the timing when expenses are incurred. The fiscal year-to-date results, when involving additional months of expense activity can provide more insight.

Fiscal year-to-date General Fund expenses totaled \$21,607,833 through August, which is \$377,354 or 1.8% higher than the amount expended last year. Through August, the largest categorical variances when compared to last year, are: transfers out lower by -\$1,000,000, and certified regular salaries higher by \$674,638.
