

TAX RATE RESOLUTION

RESOLUTION DESIGNATING THE TAX RATE FOR THE TOMBALL INDEPENDENT SCHOOL DISTRICT FOR THE FISCAL YEAR 2025-2026 TAX YEAR 2025

WHEREAS, the Board of Trustees will be levying an actual tax rate for Maintenance and Operations and an actual total tax rate that is equal to the actual tax rate levied in the prior year; AND

WHEREAS, the Board of Trustees of the Tomball Independent School District has adopted a budget for the Tomball Independent School District for the Fiscal Year beginning July 1, 2025, and ending June 30, 2026, known as the Fiscal Year 2025-2026, and the Tax Year 2025; AND

WHEREAS, the Board of Trustees of the Tomball Independent School District has found, determined, and declared that sufficient written notice of the date, time, place and subject of the meeting of the Board of Trustees of Tomball Independent School District at which this resolution was adopted was published as required by Section 44.004 of the Texas Education Code, and posted at a place convenient and readily accessible at all times to the general public at the regular meeting place of the Board of Trustees for the time preceding this meeting as required by Chapter 551 of the Texas Government Code, and that this meeting has been open to the public as required by law at all times during which this Resolution and the subject matter thereof has been discussed, considered and formally acted upon.

NOW, THEREFORE, BE IT RESOLVED THAT, an ad valorem tax of and at the rate of zero dollars and sixty-six and sixty-nine hundredths cents (\$0.6669) on the one hundred dollar (\$100.00) value thereof, estimated in lawful currency of the United States of America, be levied to pay for the maintenance and operations (M&O) of the Tomball Independent School District, for the Fiscal Year 2025-2026, the Tax Year 2025. This tax rate is the same as the tax rate that was adopted in the previous fiscal year.

BE IT ALSO RESOLVED THAT, an ad valorem tax of and at the rate of thirty-nine and six tenths cents (\$0.3960) on the one hundred dollar (\$100.00) value thereof, estimated in lawful currency of the United States of America, be levied to pay for the voter approved debt (I&S) of the Tomball Independent School District, for the Fiscal Year 2025-2026, the Tax Year 2025.

BE IT ORDERED by the Board of Trustees of the Tomball Independent School District that it is hereby levied for the Tax Year 2025, on all real property situated in and all personal property owned within the limits of said District on the first day of January, 2025, the same being the current year, except such property as may be exempt

by the Constitution and Laws of the State of Texas and/or of the United States of America, or by Resolution of the Board of Trustees of the Tomball Independent School District or its predecessor, a total of one dollar and six and twenty-nine hundredths cents (\$1.0629) on the one hundred dollar (\$100.00) value thereof, estimated in lawful currency of the United States of America, for the maintenance and operations and debt payments of the education and general programs of the Tomball Independent School District.
