Permission Information

By signing this form, I give permission to RVUSD ELOP to participate in field trips around Covelo, including the swimming pool. Parents will be notified of out of town field trips and separate permission slips will be required. **I fully understand that participants are to abide by all rules and regulations governing conduct during any trips. Any violation of these rules and regulations may result in the student being sent home at his/her – and/or parent expense.**

I further give permission for my child to be included in photographs or videos taken by the RVUSD ELOP staff during program activities. I understand that I must provide a written notice to the ELOP Coordinator if I decline permission for my student to be included in photos or videos.

Behavior & Program Agreements

I understand that my child is expected to follow the same rules and district policies governing behavior in ELOP that are in effect during a regular school day. Any disruptive behavior that affects the program may be grounds for exclusion. Enrollment in ELOP is based upon capacity limits. If the number of registration requests exceeds the capacity, a waitlist will be established. Students are expected to participate in the activities offered if they are attending the ELOP program. Students with irregular attendance may be dropped from the program if there is a waitlist; parents are expected to notify the ELOP Coordinator if their child will not be attending the program activities. Parents are expected to be on time with student pick-up and/or be available for student drop off. Excessive late pickup or being unavailable for drop-off may be grounds for dismissal from the ELOP program.
