



## Bensenville Elementary School District 2 Mandatory Development and Training Completed by Board Members

Each Illinois school board member who is elected or appointed to fill a vacancy of at least one year’s duration must complete State-mandated professional development leadership training (PDLT) and Open Meetings Act (OMA) training. State-mandated training is also required for board members who want to vote upon a dismissal based upon the Performance Evaluation Reform Act.
