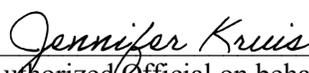

Area of Focus 1: Professional Learning

A. Provide a description of how the LEA will address Professional Learning under this section and how these activities will be aligned with Florida's challenging academic standards.

Professional learning opportunities will focus on strengthening instructional best practices to increase student achievement across all content areas. To strengthen instructional practices, teachers and administrators will be provided with professional learning to target the following areas: differentiated instruction, Universal Designed Instruction, questioning and discussion techniques, Lexia Learning, raising classroom rigor, B.E.S.T. Standards for English Language Arts K-12 and Math K-12, Discalcula and Dyslexia for ealry learning intervention, the Danielson evaluation tool, and literacy, math, science, social studies, and virtual instructional best practices. These topics have been chosen based on identified local needs and state mandates.

B. Describe the funded activities that will be implemented to address Area of Focus 1.

Activity 1	Salaries for Teaching and Learning Specialists to support teachers and administrators in professional learning throughout the year. Teaching and Learning Specialists will support teachers and administrators in the continued B.E.S.T. standards for English Language Arts and Mathematics through professional learning opportunities. Teaching and Learning Specialists will provide professional learning on evidence-based practices that will benefit teachers and administrators as instructional leaders. The Teaching and Learning Specialists will support teachers to ensure state-mandated social studies and science standards are addressed using best instructional practices. In addition, the Teaching and Learning Specialists will provide professional learning that models multisensory literacy instruction, universal design for learning principles, and strategies for supporting students with dyslexia and dyscalculia and various learning disabilities. Face-to-face support will be provided to ESE/Intervention teachers in identifying barriers to student achievement and determining strategies to reduce barriers. Curriculum Specialists will support Multi-Tier Systems of Support (MTSS) across the district for academic success by providing professional learning and support for implementation and monitoring student progress with instructional gaps.
Activity 2	Salary for a data coach at the Imagine School at Town Center Charter School. The data coach at the Charter School (ISTC) will provide professional learning opportunities in standards-based lessons, train teachers in effectively implementing curriculum associated with job-embedded training opportunities, and model lessons associated with the annually assessed standards. The LEA will fund 50% of the salary and benefits for one (1) data coach. Object code 394 will be utilized for budgeting purposes. The total for this activity, including salary and benefits, is \$31,469.46.
Activity 3	NEFEC provides professional and technical services in the form of training for teachers and administrators throughout the year. These opportunities are face-to-face and online for teachers as well as school-based administrators. NEFEC also provides data related to the retention of teachers and how to effectively support them. The NEFEC Instructional Services Program (ISP) portion of the contract is in the amount of \$63,997.26. Title II and the general fund split the fee 50%-50% amounting to \$31,310.00. For details about the ISP, see pp. 1, 3-5 of the contract.

Activity 4	Christ the King (CTK) will offer professional learning opportunities for teachers to participate in. They will focus on Renaissance Learning Products and Learning A-Z. The total for this is \$5,536.00. Also, other materials and supplies such as markers, Post-it notes, pens, notebooks, and folders will be purchased to support attendees during the training. The total for this activity is \$300.80. The total activity is \$5,536.00+\$300.80 = \$5,836.80. ☐
Activity 5	The Annual membership for ASCD will be purchased for 3 teachers at a rate of \$89/teacher = \$267.00. An annual membership to Daily Cafe for Christ the King will also be purchased for \$73. The total for this activity is \$340.☐
Activity 6	Christ the King will be offering professional learning for the staff for Renaissance Learning and Learning A-Z. Additional materials and resources will be required for the training sessions for teachers that will last longer than one year. The total cost for this activity is \$350.00.
Activity 7	First Baptist (FBCA) will continue to host several PD opportunities for teachers to participate as well as participate in regional professional learning opportunities. Teachers will participate in professional learning, such as the FACCS Conference, with an emphasis on core instructional support and benchmark alignment to state standards. In addition, travel to professional learning opportunities and conferences that include core instructional models, high-yield effect strategies and cooperative learning environments. The funds for this would \$14,758.60. FBCA will also continue its professional learning through book studies. This projected cost is \$1,493.62. In addition, materials and other materials and supplies such as markers, post-it notes, pens, notebooks, and folders will be purchased to support attendees during the training. The total cost is \$1,493.62. The total for this activity is \$14,758.60 + \$1,493.62 + \$1,493.62 = \$17,745.84.☐
Activity 8	Suncoast Coast Community School will hold several PD opportunities for teachers to participate. The teachers will participate in these professional learning opportunities that include student engagement, conflict resolution, and Close Reading. In addition, Suncoast will provide professional learning in Wilson's Foundation for ELA. The total for this professional learning is \$5,000.00. In addition, professional learning materials support the PL as well as professional learning through book studies. The total for this would be \$1,750.00. Suncoast will purchase materials and other materials and supplies such as markers, post-it notes, pens, notebooks, and folders will be purchased to support attendees during the training for a total of \$454.31. Suncoast will also pay for four teachers to renew their teaching certification at \$225.00 per person. The total would \$225.00. The total for this activity is \$5,000.00 + \$1,750.00 + \$454.31 + \$225.00 = \$7,302.96.
Activity 9	St. Elizabeth Ann Seaton will host a PD opportunity for teachers to participate in this year in August. Teachers will participate in professional learning offered by Conflict Resolution Systems. The training will include topics on bullying, cyber-bullying, classroom management and critical thinking to resolve conflicts with a focus on Resiliency. The cost for the Conflict Resolution Systems will total \$3,500.00. In addition, another opportunity for professional learning will focus on students with disabilities and how to close instructional gaps. The cost for this training is \$3,379.60. The total for this activity is \$6,879.60.
Activity 10	Teaching and Learning Specialists and administrators attend out-of-county professional learning in the areas of ELA, math, science, social studies, leadership, WIDA, UDL, the use of data, early childhood education, behavior management, Advanced Placement, Cambridge AICE, and International Baccalaureate studies. Travel also includes attendance at the Florida Association of Mathematics Supervisors (FAMS), Florida Council of Teachers of Mathematics (FCTM), Florida Association of Science Supervisors (FASS), Curriculum of Language Arts Supervisors (CLAS), Florida Associations of Media Educators (FAME) and Florida Organization of Instructional Leaders (FOIL). In addition, our school-based administrators attend the NEFEC Summer Leadership Institute. These trainings occur throughout the year and are important to keep everyone abreast of the latest educational developments and best practices. Registration for FAMS, FASS, FASSS, CLAS, and FOIL is typically \$75 per person and hotel fees are typically \$175/night. The total cost for this activity is \$16,417.67.☐
Activity 11	Coastal Community School is bringing online professional learning modules to assist with cross-curricular instruction \$1,500.00. In addition, materials and other materials and supplies such as markers, post-it notes, pens, notebooks, and folders will be purchased to support attendees during the training. The total cost is \$87.60. The total cost for this activity is \$1,587.60
Activity 12	Teaching and Learning Specialists travel to schools to support teachers and travel to out-of-county conferences in district vehicles. Costs associated with vehicle maintenance and gasoline may be incurred for professional learning activities requiring teachers and other school leaders to travel in and out of the county. The total cost for this activity is \$1,250.00. ☐
Activity 13	Teachers are paid a stipend for participating in after-hours and summer professional learning. The stipend is \$35 after hours and \$210 per day during the summer, plus benefits. In order to receive the stipend, teachers must complete the follow-up activity. Teachers may receive a stipend for attending Solution Tree, NEFEC, and district lead professional learning and other training through Title II. The total for this activity is \$24,300.00 plus benefits of \$2,51.32. The total cost for this activity is \$26,351.32. ☐
Activity 14	We will continue to offer reading endorsement training. We found that it is more cost-efficient to develop our courses to provide to our teachers using our in-house instructor. By developing our courses, we could reduce the costs associated with supporting our teachers in obtaining their reading endorsement. Teachers who are identified by their principals as needing to become certified in a new field are reimbursed for the subject area exam and the certification application fees upon proof of passing and payment, as allowed by the budget. This helps to ensure that teachers are teaching in the field. Subject area exams reimbursement = \$150 plus an additional \$75 certification application fee, for a total of \$225 per teacher. The total cost for this activity is \$5,000.00. ☐
Activity 15	When teachers are out of their classrooms to attend training or conferences in the areas of best instructional practices, ELA, math, science, social studies, leadership, WIDA, UDL, the use of data, early childhood education, behavior management, Advanced Placement, Cambridge AICE, and International Baccalaureate studies, substitute teachers are provided. \$6,000.00 is set aside for substitutes and \$500.00 for benefits. The total cost for this activity is \$6,500.00.
Activity 16	Materials and Supplies are needed when providing professional learning opportunities, whether they occur after school, over the summer, or as job-embedded training. The total cost for this activity is \$2,000.00.
Activity 17	Atlas Academy is a new private provider for our area. They are focusing on professional learning online through workshops that target standards-based instruction. Total for this is \$776.10, which is also the total for this activity.
Activity 18	Solution Tree Leadership offers professional learning opportunities for school-based administration and school-based instructional leaders to strengthen Professional Learning Communities on campuses to increase student achievement. The total cost for this activity is \$7,500.00.

Assurance 4: The LEA assures they shall adhere to the provision of services under section 1423(2) and program requirements under section 1425 for any correctional facility to which the LEA has agreed. [Section 1423].

Assurance 5: The LEA assures they shall evaluate the program not less than once every three years to determine the program's impact on student outcomes. [Section 1431].

Title II, Part A: Supporting Effective Instruction

Assurance 1: The LEA assures they will comply with section 8501 (regarding participation by private school children and teachers). [Section 2102(b)(2)(E)].

Assurance 2: The LEA assures they will coordinate professional development activities authorized under this part with professional development activities provided through other Federal, State, and local programs. [Section 2102(b)(2)(F)].

Assurance 3: The LEA assures they will reduce class size to an evidence-based level, to the extent the State (in consultation with local educational agencies in the State) determines that such evidence is reasonably available, to improve student achievement through the recruiting and hiring of additional effective teachers.

Assurance 4: Collaboration - The local educational agency (LEA) assures that, in developing the application, an LEA shall provide meaningful consultation with teachers, principals, other school leaders, paraprofessionals (including organizations representing such individuals), specialized instructional support personnel,

Assurance 5: Professional Development - The LEA assures they will meet the statutory professional development definition as provided in ESEA section 8101(42) or other allowable uses of funds under section 2103(b)(3) of the ESEA.

Title III, Part A: English Language Acquisition, Language Enhancement and Academic Achievement

Assurance 1: The LEA assures that it will comply with section 1112(e) – Parents' Rights-to-know, before, and throughout, each school year as of the date of application. [Section 3116(b)(4)(A)].

Assurance 2: The LEA assures that it is not in violation of any State law, including State constitutional law, regarding the education of English learners, consistent with Sections 3125 and 3126. [Section 3116(b)(4)(B)].

Assurance 3: The LEA assures that each school with English learner (EL) students receives funds from non-Federal sources to fulfill the LEA's obligations under Title IV of the Civil Rights Act of 1964 and the Equal Educational Opportunities Act, before using Title III, Part A funds for languages services to EL students. [Section

Assurance 4: The LEA assures that, if applicable, it will coordinate activities and share relevant data under its plan with local Head Start and Early Head Start agencies, including migrant and seasonal Head Start agencies, and other early childhood education providers. [Section 3116(b)(4)(D)].

Assurance 5: The LEA assures that it will consult with officials of private schools in a timely and meaningful manner to make available equitable Title III, Part A services to eligible English learners and immigrant children attending private schools located within the LEA's geographical boundaries. [Section 8501].

Assurance 6: The LEA assures that the current ELL population has enough students to generate the \$10,000 threshold as indicated in Section 3114. [Section 3114 (c)].

Assurance 7: The LEA assures that not more than 2 percent of the LEA's Title III allocation will be used for the cost of administering the project. [Section 3115 (b)].

Assurance 6: The LEA assures that it will annually report to the State for inclusion in the report described in section 4104(a)(2) how funds are being used under this subpart to meet the requirements of subparagraphs (C) through (E). [Section 4106(e)(2)(F)].

Assurance 7: The LEA assures that the LEA, or consortium of such agencies, shall develop its application through consultation with parents, teachers, principals, other school leaders, specialized instructional support personnel, students, community-based organizations, local government representatives (which may include

Assurance 8: with the exception of LEAs outlined in section 4109(f)(2), the LEA, or consortium of such agencies, shall conduct a comprehensive needs assessment of the local educational agency or agencies proposed to be served under this subpart in order to examine needs for improvement. [Section 4106(e)(2)(G)]. The

Title V, Part B, Subpart 2: Rural and Low-Income Schools

Assurance 1: The LEA assures that its project funds under Title V, Part B, subpart 2 will be used for any activities authorized under the following ESEA Title programs: Title I, Part A; Title II, Part A; Title III, Part A; Title IV, Part A; and parental involvement activities. [Section 5222(a)].

Assurance 2: The LEA assures that its project funds under Subpart 2 will be used to supplement, and not supplant, any other Federal, State, or local education funds. [Section 5232].

Assurance 3: The LEA assures that 20 percent or more of the children ages 5 through 17 years served by the LEA are from families with incomes below the poverty line. [Section 5221(a)(3)(C) (b)(1)(Ai)-(B)]

Assurance 4: The LEA assures that if eligible for funding under both this subpart and subpart 1, it will not receive funds under both subparts for such fiscal year. [Section 5225(a)]
