Dear Parent/Guardian,

Your child may be eligible to enroll in the Indigenous Education Program if you, your child, or your child's grandparent is an enrolled member of a federally recognized tribe.

Indigenous Education supports American Indian and Alaska Native students by providing school-based supports to meet and exceed state academic and cultural standards. Upon enrollment, your child will be eligible to participate in various (K-12) programs including:

- Cultural Enrichment
- Summer Programs
- Academic enrichment and cultural identity
- Native Advisory Committee (parents too)

Attached is the TITLE VI STUDENT ELIGIBILITY CERTIFICATION (506) FORM. Complete the entire 506 form and return the signed original to your child's school office or email it to 506@asdk12.org. Be sure to include an enrollment number or a copy of documentation (CIB, village or tribal ID, etc.). The address of the "Organization maintaining membership" is needed.

The 506 form is required for student eligibility and is used to generate federal funding for the Indigenous Education program. However, enrollment in the program does not obligate a student to participate.

If your family does not have documentation or declines eligibility for Indigenous Education services, please write "No documentation" or "Decline" on the form, along with your student's name and date of birth and return it to your school office or email it to 506@asdk12.org. If you change your mind or acquire documentation please contact the Indigenous Education office at (907) 742-4445.

Definitions:

Indian means an individual who is (1) A member of an Indian Tribe or Band, as membership is defined by the Indian Tribe or Band, including any Tribe or Band terminated since 1940, and any Tribe or Band recognized by the State in which the Tribe or Band resides; (2) A descendant of a parent or grandparent who meets the requirements described in paragraph (1) of this definition; (3) Considered by the Secretary of the Interior to be an Indian for any purpose; (4) An Eskimo, Aleut, or other Alaska Native; or (5) A member of an organized Indian group that received a grant under the Indian Education Act of 1988 as it was in effect on October 19, 1994.

Student Information: Write the name of the child, date of birth, grade level, name of school and school district. Only name one child per form.

Tribal Membership: Write the name of the individual with the tribal membership, if it is not the child listed. Only one name is needed for this section, even though multiple persons may have tribal membership. Select only one identifier: the child, child's parent or grandparent, for whom you can provide membership information.

Write the name and address of the organization that maintains updated and accurate membership data for such Tribe or Band of Indians.
