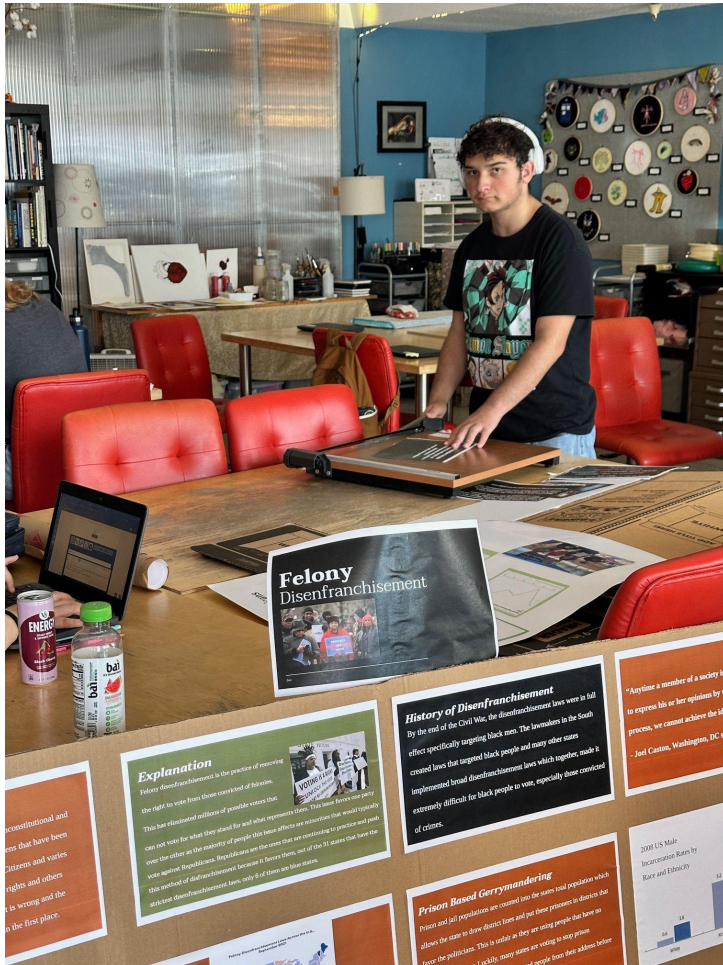

ICE Protocols + Student Safety

ICE almost never has a judicial warrant necessary to enter private spaces—be wary of ICE

JUDICIAL WARRANTS v. IMMIGRATION WARRANTS
