APG Changes - CTE

Remove or Add	Course	Rationale
Add	PLTW Engineering Design & Process	TEA change to replace Innovative course PLTW Introduction to Engineering Design; no curriculum or programmatic changes.
Add	PLTW Aerospace Design I	TEA change to replace the Innovative course PLTW Aerospace Engineering I; no curriculum or programmatic changes.
Add	PLTW Civil Engineering I	TEA change to replace the Innovative course PLTW Civil Engineering & Architecture; no curriculum or programmatic changes.
Add	PLTW Design & Problem Solving	TEA change to replace the Innovative course PLTW Eng. Design & Development; no curriculum or programmatic changes.
Add	Digital Design & Media Production	New 1 credit course offered to Seniors in the Digital Communications program. This will increase CCMR completion for all students that do not have availability for a 2 credit practicum course.
Add	Small Unmanned Aircraft Systems	Innovative course for UAV Drone Pilots 4th year
Remove	Printing & Imaging Tech II/Lab	We combined this program with Commercial Photography last year and removed Print & Image I for 25-26; this is the phase out plan for removing one course per year to allow the current cohort of students to complete their program of study.
Remove	Accounting & Financial Services Program	We no longer offer Accounting at any high school. Accounting topics are covered in business classes for Business Management students. Deletion from Academic Planning Guide will reflect correct offerings.

APG Changes - CCMR

Remove or Add	Course	Rationale
Add	OnRamps Government	Addition of an OnRamps option that would allow students to take an in-person dual-enrollment Government senior year, pairs well with economics or personal financial literacy as a half credit.
