Campus Executive Summary

Demographics:

Sgt. L. Trevino Elementary serves students from three different cities, who come from similar backgrounds and way of life. The student body at PSJA ISD is majority Hispanic with the following breakdown of student populations:

Economically Disadvantaged	92.6%
EB	58.4%

With the district's proximity to Mexico, 58.4% of the students are considered Emergent Bilingual (EBs) with Spanish being the language spoken at home, and 88.6% of the population is Hispanic.

Student Performance:

Using preliminary student performance data, Sgt. L. Trevino Elementary has been rated a "D" campus by the state of Texas on the 2025 Accountability. In Domain I, Student Achievement Domain, STAAR Performance was at a score of a 64 (D).

In Domain II, School Progress 72 (C), Academic Growth 59 (F) and Relative Performance 72 (C) with an Eco Dis at a 98%, Trevino earned a scale score of 72 (C). Domain III, Closing the Gaps Domain, Trevino's scale score was an 63 (D).

The overall 2025 Accountability Rating for Sgt L. Trevino Elementary was a score of 69 (D). In grades 3-5 all tested STAAR subjects Trevino Elementary administered 369 tests which translates to over 99% participation for the 2024-2025 school year.

Executive Summary Continued

Overall Performance Trend

From 2023 to 2025, the campus showed progress in 2024 followed by a sharp decline in 2025 across nearly all accountability domains. The steepest declines were in Academic Growth and Closing the Gaps, while TELPAS performance remained steady.

Key Strengths

- English Language Proficiency (TELPAS): Steady at 56–57% across all three years, consistently earning full points.
- RLA Achievement: Improved in 2024 with Meets rising to 51% before slipping in 2025.
- Relative Performance: Reached its peak in 2024 (Scaled Score = 82).
- Emergent Bilingual Students: Notable gains in 2024 before the 2025 dip.

Areas of Concern

- STAAR Performance: Declined in 2025 across all subjects (Approaches 74% → 62%; Meets 47% → 37%).
- Academic Growth (Part A): Dropped from 77 (2023) → 67 (2024) → 55 (2025), with Math showing the steepest decline.
- Relative Performance (Part B): Fell from 82 (2024) → 72 (2025) as Eco Disadvantage % rose (96.1% → 98.0%).
- Closing the Gaps (Domain III): Collapsed from 74 (2023) → 61 (2024) → 18 (2025).
- SPED Outcomes: Approaches decreased to 38% in 2025, widening performance gaps.

Root Causes

- Misalignment between instruction and STAAR-tested standards.
- Gaps in intervention systems for Math and Science.
- Weaknesses in monitoring and sustaining accelerated learning interventions.
- Barriers related to attendance and consistency of instructional delivery.

Priorities for 2026

- Improve Math & Science outcomes with stronger Tier 2 & 3 interventions. (increase approaches and meets for Math, Science, & RLA)
- Strengthen SPED & continuously enrolled supports and differentiated instruction
- Sustain TELPAS progress while closing STAAR gaps in RLA and Math.
- Rebuild Accelerated Learning systems and growth monitoring.
- Improve attendance and engagement to support overall achievement.

Executive Summary Continued

Effective Teaching and Learning:

PSJA ISD Curriculum & Instruction Office oversees implementation of a TEKS aligned curriculum that is relevant, rigorous and engaging for all PSJA ISD students.

Alignment of the curriculum is an ongoing process and includes integration of TEKS Resources, development of a comprehensive curriculum, as well as intensive and relevant continuous professional learning. Curriculum, programs, and resources are reviewed, and adjustments are made based upon collaborative analysis of student data and the emergence of new research.

All PSJA ISD comprehensive high schools are designated Early College, which makes them innovative high schools that allow students to attend college and high school simultaneously. Early College High Schools offer rigorous instruction and provide academic, social, and emotional support services to help students succeed.

Starting in the 2023-2024 academic year, PSJA ISD implemented the UN's 17 Sustainable Development Goals (SDGs) across its entire school system.

The district is:

1. Integrating SDGs into their curriculum to give students practical, real-world knowledge and experience for global competitiveness
2. Taking a system-wide approach to sustainability through a multi-departmental committee
3. Coordinating efforts across various departments including Curriculum, HR, Operations, Health Services, Construction, Transportation, Child Nutrition, Police, and Communications

Additionally, PSJA ISD offers a Dual Language Program as an academic experience designed for students to develop stronger cognitive and academic skills through the development of on-level bilingualism and biliteracy. Through a rigorous curriculum, students who participate in the program are academically instructed in Spanish and English, from Pre-Kinder to 12th grade.

As a result, students can master both languages and enhance their education by developing the ability to fluently speak, read, write, and think critically in Spanish and English, which allows them to compete successfully in a global economy.

Furthermore, PSJA ISD teachers are equipped and trained to teach rigorous content and make learning experiences memorable preparing all students for the competitive world. Advance Placement at all high school campuses offers students the opportunity earn post-secondary credentials if they earn a three or higher. Currently, 216, Met the criterion score on an AP/IB exam in any subject translates to 10%.












4a. Overall Growth Scores (All Subjects)




4b. Annual Growth Rate by Subject

Emergent Bilingual (EB): The following sources from across the district were used to review the Bilingual Education/Dual Language (BE/DL) Department data by the District Education Improvement Council: State of Texas Assessments of Academic Readiness (STAAR) results, Performance Based Monitoring Assessment System (PBMAS) and TELPAS indicators to determine strengths and needs of our EB students. The BE/DL Department also worked closely with the human resource department to ensure that highly qualified teachers and instructional assistants were recruited, hired, and placed in the appropriate educational setting. Each curriculum and instruction central office administrator by campus type was also assigned an English Language and Spanish Language Development coach to enhance bi-literacy. In addition, the BE/DL Department was very involved in the curriculum writing and revision for grades K-12 during the summer to address the needs of our EB students and align the curriculum between English and Spanish Language Arts that led to a more coherent and consistent bi-literacy program. Professional development was also coordinated with the curriculum and instruction department to ensure that all general education teachers utilize best practices that support the learning of ELL students.

Title I, Part A

School wide Components:

- 1. A comprehensive needs assessment of the entire school (including considering the needs of migratory children as defined in section 1309(2)) that is based on information which includes the achievement of children in relation to the State academic content standards and the State student academic achievement standards described in section 1111(b)(1).**
- 2. School wide reform strategies that provide opportunities for all children to meet the State’s proficient and advanced levels of student academic achievement, use effective methods and instructional strategies that are based on scientifically based research, and that include strategies to address the needs of all children in the school, but particularly the needs of low-achieving children and those at risk of not meeting the State student academic achievement standards who are members of the target population of any program that is included in the school wide program.**
- 3. Instruction by highly qualified teachers.**
- 4. In accordance with section 1119 and subsection (a)(4), high-quality and ongoing professional development for teachers, principals, and paraprofessionals and, if appropriate, pupil services personnel, parents, and other staff to enable all children in the school to meet the State’s student academic achievement standards.**
- 5. Strategies to attract high-quality teachers to high-need schools.**
- 6. Strategies to increase parental involvement in accordance with section 1118, such as family literary services.**
- 7. Plans for assisting preschool children in the transition from early childhood programs, such as Head Start, Even Start, Early Reading First, or a State- run preschool program, to local elementary school programs.**
- 8. Measures to include teachers in the decisions regarding the use of academic assessments described in section 1111(b)(3) in order to provide information on, and to improve, the achievement of individual students and the overall instructional program.**
- 9. Activities to ensure that students who experience difficulty mastering the proficient or advanced levels of academic achievement standards required by section 1111(b) (1) shall be provided with effective, timely additional assistance which shall include measures to ensure that student difficulties are identified on a timely basis and to provide sufficient information on which to base effective assistance.**
- 10. Coordination and integration of Federal, State, and local services and programs, including programs supported under this Act, violence prevention programs, nutrition programs, housing programs, Head Start, adult education, vocational and technical education, and job training.**
