### **Purpose and Scope of the Committee**

The Issaquah School District Capital Projects Oversight Committee (CPOC) is established to ensure the responsible management of bond and levy funds approved by voters. The committee's role is to review expenditures, monitor project progress, and ensure compliance with the approved bond and levy requirements. The CPOC will serve as a transparent accountability measure, providing assurance to the community that bond and levy funds for capital projects are being managed effectively and in accordance with district objectives.



### The top themes that committee members asked or commented about are:

### Financial Transparency and Accountability

- Strong interest in understanding how bond and levy funds are allocated, repurposed and repaid.
- Requests for more detailed financial data to reinforce confidence in fiscal decisions (e.g., Tech Levy spending).
- Opportunity to highlight responsible financial stewardship and align with voter-approved purposes.

### **Bond Challenges and Public Trust**

- Open discussions about the factors influencing the November 2024 and February 2025 bond results.
- Acknowledgment that new leadership is making a positive impact and can help rebuild public trust.
- Strong interest in promoting transparency and broadening outreach leverage storytelling to address main concerns.
- A strong desire to attend facilities to see projects in progress and completed.
- Commitment to correcting misinformation and strengthening relationships with key community groups.

### **Overcrowding and Enrollment Growth**

- All committed to the district delivering on its promise to use funds and build infrastructure to support overcrowding.
- Active engagement in understanding enrollment projections and their impact on school capacity.
- Personal student experiences highlight the need for long-term planning and investment in facilities.
- Shared commitment to finding solutions that support student success in safe and effective learning environments.
