Reading Recovery and CIM will be implemented along with the Comprehensive Literacy Model (PCL). Balanced math will be implemented aligned with Math Recovery and Math Advantage. These research models include collaboration with the classroom teacher. Layers of support will be implemented.

The implementation of the Comprehensive Literacy Model (PCL) is aligned with best practices that support the academic program. The components include classroom instruction aligned with tiered interventions. It is built with the support of the trained PCL coach. The workshop model will small group, whole group, and 1:1.

Balanced math - built on best practices will strengthen classroom delivery increased use of manipulatives aligned to Math Recovery/Math Advantage

Data will be analyzed to target interventions. Data is about informing instruction. The CIM model will be used for literacy. The strategies of Math Recovery/Math Advantage will be used. The focus will be on the individual student strengths/needs and instruction will be planned with this focus in mind. Emphasis will be on informing instruction.

Job embedded professional development is a key component. Team meetings & PLC meetings will include professional development. Coaches will receive additional training around best practice implementation, targeted interventions and data analysis. They will use this as they prepare professional development for the staff. The professional development will be the layered for staff. Reading interventionists will receive training and support regarding best practices including implementation of Reading Recovery and CIM with fidelity. Principals, interventionists and teachers will receive additional training and support around best practices, targeted interventions, data analysis and collaborative instructional conversations. The district will continue RTI (Response to Intervention) professional development that will enable teachers to identify tier I strategies for students which will enhance their learning. Assessment and engagement training for the district will be layered in with the RTI so that teachers can measure the effectiveness of their teaching by linking student performance to specific learning objectives.
