School, Parent, and Family Engagement Policy

PART I. GENERAL EXPECTATIONS

- 1. BA will take the following actions to involve parents in the joint development of its school parental involvement plan under section 1118 of the ESEA:**

- 6. BA will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:**

- providing opportunities for parents to meet with school personnel to discuss these scores
7. BA will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not certified in the area which he/she teaches by:
- sending home a letter explaining the situation, signed by the principal
 - providing additional information at parents' request
8. BA will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph –
- the state's academic content standards,
 - the state's student academic achievement standards,
 - the state and local academic assessments including alternate assessments,
 - the requirements of Part A,
 - how to monitor their child's progress, and
 - how to work with educators:
 - parent/teacher conferences
 - progress reports and report cards
 - state assessment calendar and reports
 - annual Title I meetings
 - Parent University workshop
 - FAFSA workshop
9. BA will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:
- Parent University workshop
 - OnCourse Workshop
 - FAFSA workshop

10. BA will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parent and schools, by:
- holding publicized conferences/meetings
 - home visits (Graduation Coach)
11. BA will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, public preschool, and other programs.
