Protect Yourself / Protégete

- Remain silent
 - Guardar silencio
- Don't open the door

I, the undersigned officer of the United States, by virtue of the power and authority vested in the Attorney General under the laws of the United States and by his or her direction, command you to take into custody and remove from the United States the above-named alien, pursuant to law, at the expense of the appropriation. "Salaries and Expenses Immigration and Naturalization Service 2002," including the expense of an attendant if necessary.

Prepare / Prepárate

- Talk to an Immigration Attorney
 - Hablar con un abogado de inmigración
- Apply for US Citizenship (if eligible)
 - Aplicar para ciudadanía (si calificas)
- Carry proof of status or 2+ years of US residency
 - Llevar pruebas del estatus migratorio o presencia por 2+ años en los EE.UU
- Apply for passports for US citizen children
 - Aplicar para pasaportes para hijos ciudadanos de los EE.UU
- Make a family plan
 - Hacer un plan familiar



Standby Guardianship (Maryland)

- (In Maryland) Use Standby Guardianship to designate a third-party to care for children
 - (En Maryland) Utiliza Standby Guardianship para nombrar a un tercero para el cuidado de tus niños
- (In Maryland) Use a Power of Attorney to designate a third-party to engage in financial transactions
 - (En Maryland) Utiliza un Poder para nombrar a un tercero para realizar transacciones financieras



PARENTAL DESIGNATION AND CONSENT TO THE BEGINNING OF STANDBY GUARDIANSHIP (Estates and Trusts § 13-904)

NOTE: Use this form to designate an adult to be standby guardian of your minor child(ren) if you become mentally incapacitated, physically debilitated, or subject to an adverse immigration action.

- **Mentally incapacitated:** Your attending physician determines you have a mental impairment that causes a chronic and substantial inability to understand the nature and consequences of decisions about the care of your child(ren). Because of the incapacity, you cannot care for your child(ren).
- **Physically debilitated:** Your attending physician determines you have a physically incapacitating illness, disease, or injury that causes a chronic and substantial inability to care for your child(ren).
- **Subject to an adverse immigration action:** You are arrested or apprehended by law enforcement for an alleged violation of federal immigration law; detained by or in the custody of the Department of Homeland Security (DHS) or a federal, state, or local agency authorized by or acting on behalf of DHS; must leave the United States under an order of removal, deportation, exclusion, voluntary departure, expedited removal, or a stipulation of voluntary departure; subject to the denial, revocation, or delay of the issuance of a visa or transportation letter by the Department of State; subject to the denial, revocation, or delay of the issuance of a parole document or reentry permit by DHS; or denied admission or entry into the United States by DHS.

- ICE Detainee Locator: <https://locator.ice.gov/odls/#/search>
 - Takes up to 72 hours to update
 - *Tarda hasta 72 horas en ser actualizado*
 - If not released, will be transferred out of Maryland
 - Si ICE no le suelta, será trasladado a un sitio fuera de Maryland
- Immigration Court / Corte de Inmigración: <https://locator.ice.gov/odls/#/search>
 - Requires Alien Number (A#)
 - Se requiere el Número de Extranjero (A#)
