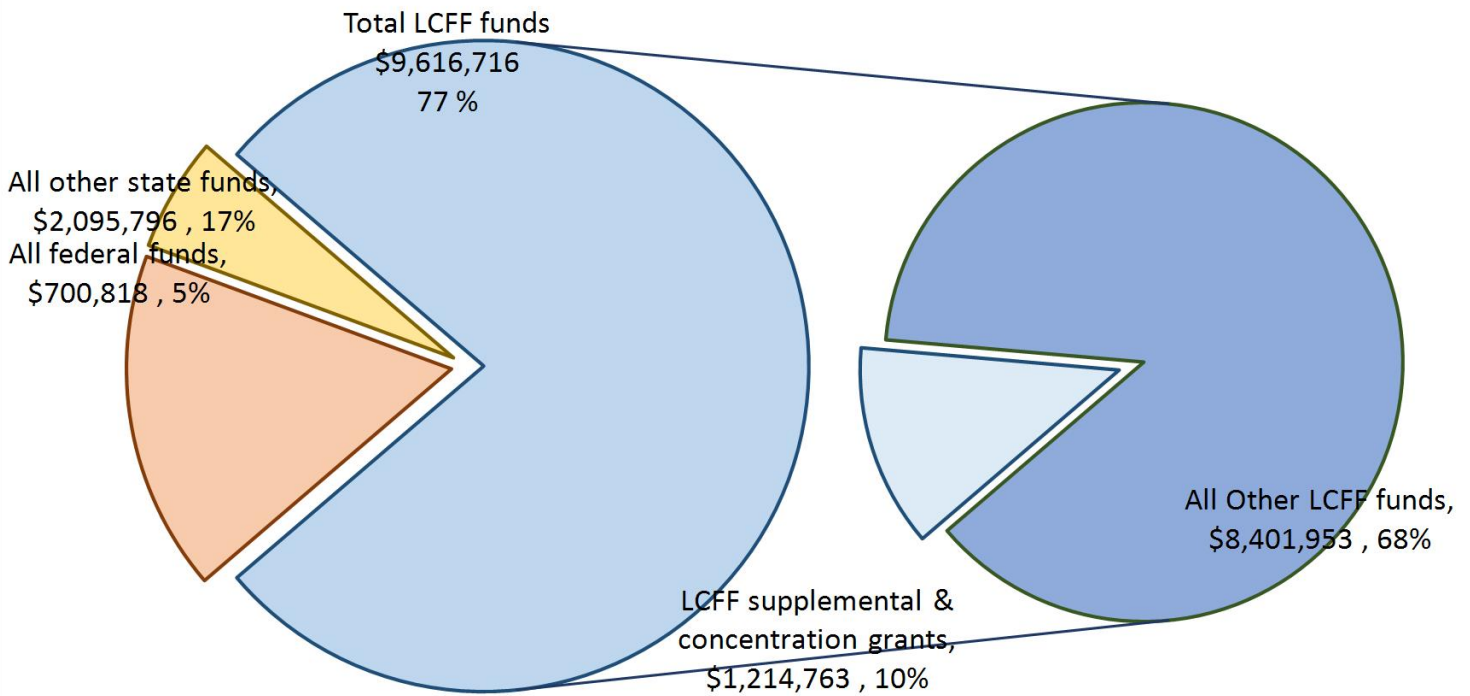

Projected Revenue by Fund Source

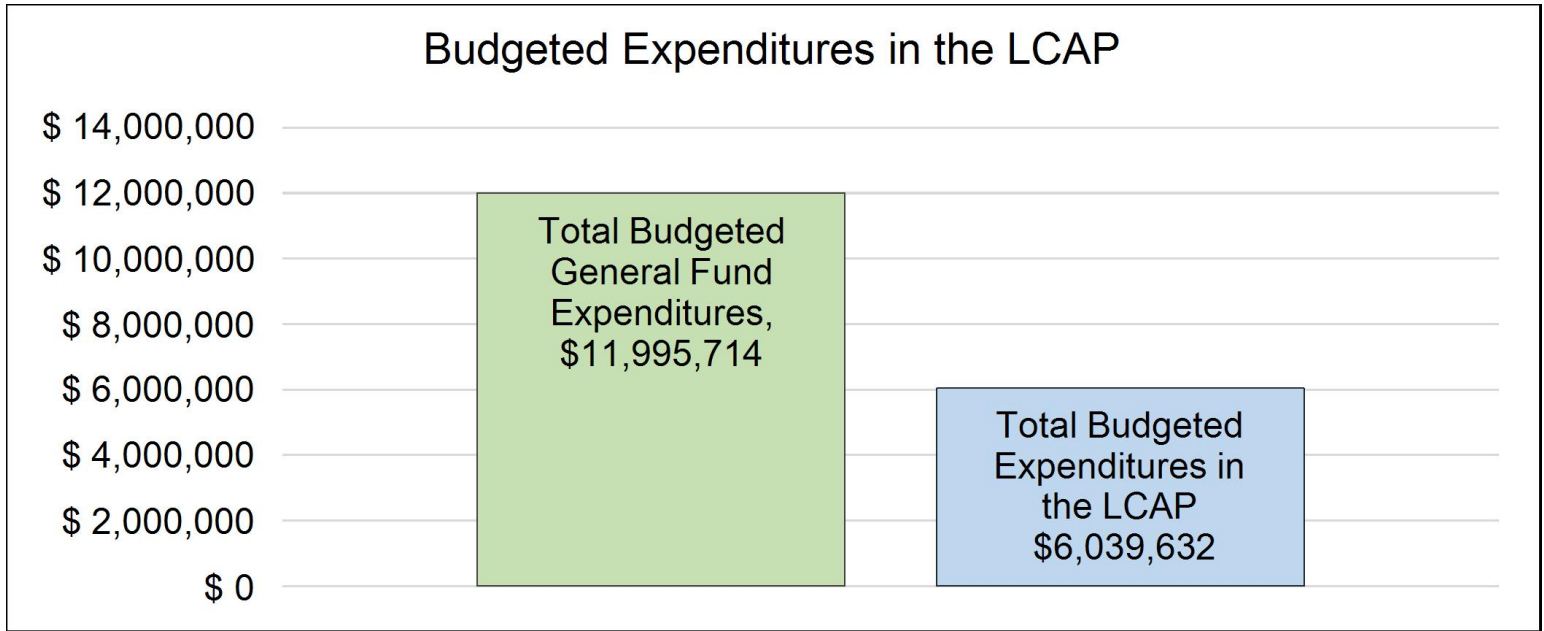


This chart shows the total general purpose revenue Aspire Benjamin Holt College Preparatory Academy expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Aspire Benjamin Holt College Preparatory Academy is \$12,413,330, of which \$9,616,716 is Local Control Funding Formula (LCFF), \$2,095,796 is other state funds, \$0 is local funds, and \$700,818 is federal funds. Of the \$9,616,716 in LCFF Funds, \$1,214,763 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

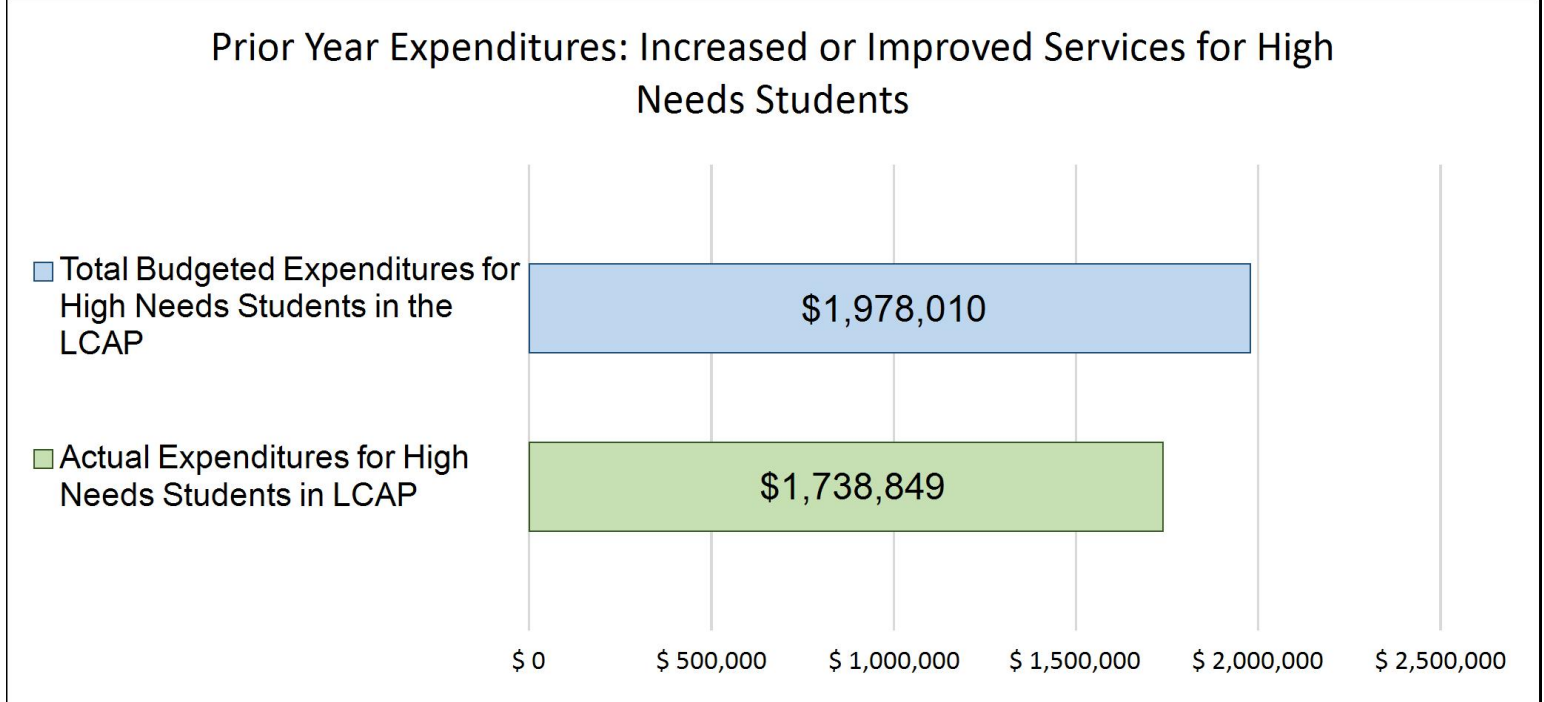

In 2025-26, Aspire Benjamin Holt College Preparatory Academy is projecting it will receive \$1,214,763 based on the enrollment of foster youth, English learner, and low-income students. General Information

Aspire Benjamin Holt College Preparatory Academy (BHA) is a 9-12 school located in Stockton, California. Since opening its doors in 2003, BHA has been part of the Aspire Public Schools network, providing a rigorous and supportive learning environment designed to prepare students for college and beyond. With a student enrollment of 695, BHA serves a diverse student body, with 49% of students identifying as Hispanic, 26% as Asian-American, 8% as Caucasian, 7% as African-American, and 7% as multiracial. Approximately 37% of students qualify for free or reduced lunch, reflecting the school’s commitment to serving students from various socioeconomic backgrounds.

Under the leadership of Principal Wesley Frakes, BHA focuses on fostering academic excellence and social development. The staff is committed to maintaining high expectations for all students while providing a nurturing and inclusive environment. Collaboration between students, teachers, parents, and the community is central to the school’s approach, as BHA aims to help students believe in themselves, gain knowledge, and develop the social skills necessary to thrive in their communities and future endeavors.

BHA provides a comprehensive academic program designed to equip students with the critical thinking, problem-solving, and leadership skills needed for success in college and life. The school integrates academic rigor with character development and community engagement, offering students opportunities to grow both academically and personally.

The school’s vision is to empower scholars to build fulfilling and liberated futures for themselves and their communities. Its mission focuses on providing a joyful and rigorous academic experience that nurtures students’ unique talents and skills while addressing systemic barriers that affect marginalized communities, including Black, Latino/a/x, Indigenous, and People of Color.

As BHA continues to grow and enhance its programs, it remains a place where students are encouraged to achieve their full potential. Through the dedication of its staff and strong community partnerships, Aspire Benjamin Holt College Preparatory Academy is committed to fostering a culture of excellence, inclusivity, and opportunity for all students.

Reflections: Annual Performance

We do not have unspent LREBG funds from the prior year. However, with the potential for new LREBG funds to be dispersed in 2025-26, we have incorporated new actions to reflect the use of these funds per the Ed Code requirement and the required needs assessment. The rationale for each action and how it is expected to address the areas of need are included in the action descriptions in the LCAP.

Successes:

Notable successes are improvements to overall student achievement, significant decrease in BHA's Chronic Absenteeism, and improvement of the year-over-year suspension rates. This was achieved through dedicated committees designed to study and implement improvement strategies. These committees are named MTSS Instruction, MTSS Attendance, and MTSS Student School-Wide Discipline teams.

Challenges:

We identified challenges in accelerating BHA's Chronic Absenteeism to further reduce this number below the current 11.7% goal, increase ELPI achievement, increasing SPED achievement, and continue to reduce suspension rates below our internal goal of 2.5 (at the time of this writing, the rate is 1.1%). The BHA ELPI student count is 12, with many of these students being identified as long term English learners (LTELs), which increases the urgency to increase student achievement within this group. Currently our SPED population is significantly behind our general education population in terms of math and ELA achievement, and overall grades received.

Actions Taken:

To address these challenges, we have implemented rideshare opportunities for our families through Ever-Driven, along with weekly MTSS Attendance meetings with the front office to identify those students in need of supports..These actions are designed to support our students and families that may be considered blended families and those that may have specific transportation needs. and align with our LCAP goal of creating a safe learning environment for our students by providing them with safe transportation to and from school..

Specific Needs of Groups/Schools:

Additionally, we are prioritizing support for low income students and their families by connecting them with local organizations that provide specific services for their needs not just transportation, but food assistance and medical needs through building relationships with our local partners and organizations. BHA 's intervention team, as well as our MTSS team has identified specific students within this subgroup and is

targeting instructional interventions to supports these students. These targeted efforts are designed to close gaps and promote equity across our entire school.

Forward-Focused Reflection:

Moving forward, we will monitor progress using attendance reports, D/F quarterly reports, and ongoing achievement data to evaluate the effectiveness of our strategies. Educational Partner input will remain integral as we refine our approach and ensure our LCAP continues to meet the needs of all students.

Teachers	Teachers were engaged through bi-annual Panorama Teammate Surveys (conducted in October 2024 and February 2025), weekly grade level Team Meetings, and monthly Staff Meetings and weekly Instructional Leadership Team meetings. These engagements provided valuable feedback on classroom practices, curriculum implementation and supports, academic and behavioral needs, professional learning, and cultural awareness, all contributing to the development and refinement of LCAP goals and actions.
Principals and Admin	School leaders, including the principal and administrators, participated in weekly Admin/School Leadership Team Meetings, monthly Communities of Practice meetings, Quarterly Professional Learning Plan meetings, and bi-annual Panorama Teammate Surveys (October 2024 and February 2025). These engagements focused on schoolwide planning, resource allocation, professional learning, data analysis, and goal setting.
Other School Personnel	Non-instructional staff were engaged through the bi-annual Panorama Teammate Surveys (conducted in October 2024 and February 2025), weekly team meetings, monthly Staff Meetings. These engagements provided input on cultural and behavioral awareness, operational effectiveness, and student support services.

Feedback from families, students, and staff has significantly shaped our current LCAP priorities. Through surveys, School Site Council meetings, and one-on-one conversations, families shared their desire for more consistent communication, deeper cultural responsiveness, and greater opportunities to engage with their child’s learning. In response, we’ve expanded our communication strategies to include multilingual materials, flexible meeting times, and varied formats for engagement—including evening events, small group listening sessions, and translated resources. We’ve also prioritized making feedback loops more visible, ensuring that community input leads to tangible changes in school practices. These changes include increased family access to academic information, new systems for gathering ongoing input, and the creation of more inclusive, accessible events like Homecoming, SpringFest, and cultural celebrations.

Our LCAP has also evolved to reflect families’ interest in being active co-creators in their child’s academic journey. We’re deepening our work around family understanding of academic expectations and offering more targeted outreach to families who may face barriers to engagement. This includes hiring a pathways manager who meets regularly with groups and individuals to understand course offerings, expanded translation services, and new leadership opportunities for underrepresented voices. Additionally, student feedback has guided us to strengthen efforts around school belonging and peer relationships, particularly for students from historically marginalized backgrounds. These efforts have translated into targeted actions in the LCAP, such as SEL curriculum fidelity checks, restorative practices, and investments in culturally affirming programming. Across the board, we remain committed to ensuring that every family and student feels seen, valued, and empowered to contribute to our shared school vision.

Goal Analysis [2024-25]

Overall, Ben Holt Academy (BHA) has successfully implemented the majority of our planned actions, with notable progress in several key areas and some challenges that require continued attention.

One of our most significant successes has been our investment in professional development (PD). We have dedicated time and resources to ensuring that teachers engage in monthly grade-level, subject-team, and department meetings, which allow for curriculum internalization and alignment. These structured PD opportunities have strengthened instructional practices and supported our educators in delivering high-quality, standards-aligned instruction.

Our Multi-Tiered System of Supports (MTSS) has also seen significant development. Our process now robustly integrates attendance, behavior, mental health, and instructional needs, ensuring that student interventions are data-driven and comprehensive. This holistic approach has strengthened our ability to support students across multiple domains of their academic and social-emotional growth.

BHA has also made strides in curriculum adoption, with the successful integration of new instructional materials across various subjects. Notably, we are in the early stages of adopting a new math curriculum, in addition to the resources implemented this school year. This process is critical to ensuring that our students receive rigorous, aligned instruction that meets state and national standards.

Despite these successes, we have identified some areas that require additional focus:

Staffing Needs: Based on data analysis, we recognize the need to increase SPED staffing by one FTE in the coming year to better meet student needs and maintain instructional quality.

Common Assessments: While curriculum adoption has been a priority, the development and implementation of common formative assessments (CFAs) remain an area for growth. These assessments are integral to monitoring student progress and informing instruction.

Post-Secondary Success Plans (PSSP): We are still working on integrating PSSP data into our student information system, which will enhance our ability to track student progress toward their post-secondary goals and ensure that students are actively engaging in their success planning.

The effectiveness of BHA's actions under this goal has been generally positive, with several areas showing measurable growth and a few identifying next steps for improvement.

1.1 Grade Level Curriculum has been effectively implemented. In the 2024–25 school year, BHA adopted new curricula in ELA, History, and Spanish, and invested in ongoing professional development to support curriculum internalization through the UnboundEd framework. Additionally, BHA has achieved a 1:1 student-to-device ratio, ensuring access to digital learning. This investment in curriculum and instruction is reflected in improved student performance, including a 47-point gain in SBAC ELA DFS for all students and a 114.9-point increase for English Learners compared to the baseline.

1.2 Instruction has also proven effective, with structured data discussions occurring during monthly grade-level meetings, subject-team meetings, individual planning sessions, and weekly department meetings. This collaborative time supports Tier 1 instruction and has contributed to a 37.1-point improvement in SBAC Math DFS for all students, and a 65.9-point gain for English Learners.

1.3 Academic Program (Master Scheduling) has led to a more responsive, data-informed MTSS structure. BHA operates distinct MTSS teams for instruction, attendance, behavior, and mental health, ensuring students receive targeted supports. The chronic absenteeism rate has decreased slightly by 0.55%, and the school's graduation rate remains high at 94.2%.

1.4 MLL supports are consistently provided, with all MLL students receiving designated and integrated ELD instruction daily. While reclassification rates improved from 27.3% to 52.94%, there was a significant drop in the ELPI metric—from 78.6% to 33.3% of ELs making progress toward English proficiency—highlighting an area that will require renewed focus.

1.5 SPED services are well-supported; Education Specialists are observed regularly and participate in professional development. Notably, students with disabilities showed marked improvement on SBAC ELA DFS (a 180-point gain) and Math DFS (+85.5 points), suggesting that instructional strategies are effectively closing achievement gaps.

1.6 Black Excellence initiatives have gained traction. BHA's Black Student Union (BSU) hosted successful events, the Pro-Black Curriculum Initiative is underway, and the annual Black Excellence Awards Ceremony was well received. Despite these successes, suspension rates for Black/African American students remain high (6.5%, up from 4.9%), indicating a need to pair programming with restorative practices and Tier 1 behavior supports.

1.7 Personalized Learning is progressing. Students in grades 9–11 complete Post-Secondary Success Plans (PSSPs), though the integration of goal tracking in PowerSchool remains a growth area. BHA is currently developing a senior project to complete the sequence across all grades.

1.8 Title I funds have been strategically utilized to support two intervention teachers in ELA and Math, who work closely with the MTSS Instructional Team to deliver targeted support. This investment has contributed to iReady annual growth scores, with 57% of students meeting growth in Reading and 58% in Math in SY 2024–25.

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

Based on the analysis, the following changes have been made to enhance implementation and improve outcomes:

- 1.1 Grade Level Curriculum: BHA will be working toward a math curriculum adoption, which will follow a cycle of pilot programming prior to committing
- 1.2 Instruction: common assessments continue to need development; BHA will work with network partners to continue making progress with this action item
- 1.3 Academic Program (Master Scheduling): Students will continue to have a broad and varied opportunity to take courses associated with pathway work, aligned with A-G requirements, and preparing them for college and career exploration
- 1.4 MLL: While students receive fully designated and integrated programming; BHA's small LTEL population are not making the same achievement growth as their peers.
- 1.5 SPED: BHA will need to adjust staffing to increase our Ed Specialist team to one additional FTE.
- 1.6 Black Excellence: BHA will be working with our network partners to grow the Black Family Advisory Council
- 1.7 Personalized Learning: BHA needs to improve the recording of PSSP goals in PowerSchool
- 1.8 Title 1: BHA will work with intervention teachers to create and follow data cycles of students in the intervention case loads

Goal Analysis [2024-25]

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

Ben Holt Academy (BHA) has made significant progress in cultivating inclusive, affirming, joyful, and safe environments for scholars and staff. Our work in attendance, school climate, and facilities continues to meet or exceed standards, ensuring that students have a supportive and well-maintained learning environment. Additionally, family outreach remains a strong area of success, with ongoing efforts to provide meaningful engagement opportunities through events such as Homecoming, International Food Night, and SpringFest. While families consistently express appreciation for these opportunities, there is a continued demand for even more varied ways to connect with the school community.

One of our key areas of focus this year has been the implementation of Social-Emotional Learning (SEL). While we have made a strong start, we recognize the need to refocus on fidelity of implementation. Specifically, ensuring that learning targets for SEL lessons are consistently posted and integrated across classrooms will help reinforce these essential skills for students. Regular learning walks and fidelity checks will be essential in supporting this refinement.

Another major success has been our coaching and professional development efforts. BHA has made huge strides in ensuring that every teammate now participates in Professional Learning Plan (PLP) meetings, strengthening instructional alignment and teacher growth. However, there is still room for improvement in the frequency and quality of instructional coaching. Moving forward, BHA will continue to refine its coaching structures, focusing on enhancing feedback cycles and ensuring all educators receive meaningful, actionable coaching support.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

The effectiveness of BHA's actions to foster an inclusive, joyful, and safe environment has been overall positive, with tangible improvements in student attendance, school climate, and family engagement.

2.1 Attendance and Enrollment have improved with the weekly work of BHA's MTSS Attendance Team. These efforts have helped reduce chronic absenteeism by 0.55% according to internal Hoonuit dashboard data. Additionally, P2 attendance rose from 94.20% to 94.43%, showing consistent, if modest, gains.

2.2 SEL implementation is underway schoolwide with the full adoption of "We Do It 4 The Culture" (WDI4TC), BHA's board-approved SEL curriculum. Although in use across all classrooms, efforts are ongoing to improve fidelity of implementation, particularly around ensuring weekly posting of SEL learning targets as a schoolwide norm.

2.3 Family and Community Engagement remains a strong area, with high-participation events like International Food Night, SpringFest, and Family Lunches driving meaningful connection. However, Aspire Family Survey results show that favorable responses about Family Engagement decreased from 16% to 11%, indicating a need for more targeted outreach and varied, accessible family-facing opportunities.

2.4 School Climate systems have matured significantly. Teachers are trained in the PowerSchool Incident Management System, and BHA's MTSS Behavior Team meets weekly to review behavioral data and align supports. While schoolwide Restorative Practice training is still underway, suspension data shows increased rates—from 1.7% to 4.1% overall, with EL students at 15.8%, highlighting the urgent need to scale proactive and restorative behavior strategies.

2.5 Classroom Facilities and Student Physical Spaces continue to exceed expectations. The school's quarterly walkthroughs have maintained a "Good" rating on the Facility Inspection Tool (FIT), and all Williams Act Requirements are fully met.

2.6 Regular Coaching is a continued area of investment. 100% of teachers completed Beginning-, Mid-, and End-of-Year Professional Learning Plan (PLP) meetings, aligned to the Aspire Student Learning Framework. Coaching frequency has improved, but teammate survey

results suggest room for growth—staff-leadership relationship favorability improved from 40% to 59%, and cultural awareness/action dipped from 49% to 44%, signaling the importance of pairing coaching with relational leadership development.

- 2.1 Attendance and Enrollment: Continue with MTSS Attendance team weekly meetings, focusing on our most vulnerable populations. Increase home visits in response to data as needed.
- 2.2 SEL: Increase SEL observation and walkthroughs, with a focus on learning targets and student engagement
- 2.3 Family and Community Engagement and Outreach: Continue with traditions of International Food Night and SpringFest; BHA will refine our participation in the CVRO Black Family Advisory Group.
- 2.4 School Climate: BHA will investigate additional training opportunities for teammates who have not yet had Restorative Practices training
- 2.5 Classroom Facilities, and Student Physical Spaces: BHA will continue with our preventative maintenance program, emergency preparedness planning, and all Williams Act Requirements.
- 2.6 Regular Coaching: BHA is conducting survey of teacher experiences with instructional coaching to further inform future coaching shifts at BHA

Ben Holt Academy (BHA) has made strong progress in implementing initiatives that support rigorous academic experiences, career pathways, and staff development. One of our key successes has been the integration of PLP (Post-Secondary Success Plan) projects for 9th-11th grade students, providing them with structured opportunities to set and work toward their career, college, and community goals. Moving forward, we will expand these projects to include our senior class, ensuring all students graduate with a well-defined post-secondary plan.

BHA has continued its commitment to Student-Led Conferences (SLCs), holding them twice each year to promote student agency and goal setting. While the process is well-established, we recognize the need to improve the recording and tracking of student goals within PowerSchool, allowing for better data-driven decision-making and student progress monitoring.

In terms of staff development, BHA will refine the Professional Learning Plan (PLP) process for educators by incorporating explicit goals related to curriculum implementation, Tier 1 instructional practices (such as strategic monitoring), and student achievement data. Additionally, we continue to support educators' professional growth by ensuring access to regional affinity groups and participation in the National Equity Project: Leading for Equity training.

A significant milestone has been BHA's commitment to developing future educators through our Alder residency program. We regularly host Alder residents and are now expanding our efforts to offer resident positions specifically for developing SPED instructors, addressing a critical area of need in education.

On the college and career pathway front, BHA is making strategic moves to expand dual enrollment and early college opportunities. We are currently working to establish a partnership with CSU Stanislaus to offer additional four-year university courses for BHA students. To support this effort, we have hired a Pathway Manager and continue to foster community partnerships, such as our collaboration with San Joaquin A+, to ensure students have meaningful post-secondary opportunities.

The effectiveness of BHA's actions related to post-secondary readiness and adult learning has been generally positive, with several initiatives demonstrating clear results and others poised for continued growth.

3.1 Rigorous Projects are now implemented for students in grades 9–11, with planning and training time embedded into the school calendar. These projects align with broader academic goals, contributing to positive academic indicators such as a 14.64% increase in EAP English proficiency and a 10.37% increase in Math, as well as a 6.17% gain in A-G completion rates, now at 93.17%.

3.2 Family Involvement and Community Outreach remains a point of pride, with family-facing events like Family Lunches, International Food Night, and SpringFest contributing to strong community engagement. However, the Aspire Family Survey data shows that family engagement favorability dropped from 16% to 11%, indicating a need for broader inclusion strategies and follow-through on co-creation of student learning pathways with families.

3.3 Professional Learning for Adults continues to improve, with 100% of staff completing BOY, MOY, and EOY Professional Learning Plan cycles, a structure that ensures ongoing development and reflective practice. However, teammate survey data suggests that while there have been gains in staff-leadership relationships (+19%) and overall school climate (+19%), cultural awareness and action declined by 5%, which will be addressed through targeted adult learning and coaching supports.

3.4 Teacher Credentialing currently exceeds compliance expectations, with 100% of teachers holding valid credentials—a substantial improvement from prior years when the fully credentialed rate was 69.26%.

3.5 College and Career Readiness efforts are expanding through new partnerships with University of the Pacific and CSU Stanislaus and include early college opportunities for students. While the overall College and Career Indicator (CCI) score dipped to 72.5% (down from 87.6%), this work is already fueling renewed investment in long-term readiness planning.

3.6 Career Pathways development has accelerated with the hiring of a dedicated Pathways Manager, and through continued collaboration with organizations like San Joaquin A+. These steps lay the foundation for expanded dual enrollment options and community-based learning experiences that align with our Vision 2030 post-secondary readiness goals.

Based on the analysis, the following changes have been made to enhance implementation and improve outcomes:

- 3.1 Rigorous Projects: BHA is working toward creating meaningful project-based units for 12th grade students, in addition to the 9th-11th grade PBL lessons
- 3.2 Family Involvement and Community Outreach: BHA is requiring Student Led Conference goals to be inputted into PowerSchool moving forward
- 3.3 Professional Learning (adults): PLP goals next year will include goals about curriculum implementation, tier 1 instructional practices such as strategic monitoring, and growth data
- 3.4 Teacher Credentialing: BHA will continue to ensure 100% of teachers hold proper credentials, teachers with intern credentials keep pace to complete their coursework, and that BHA continues its relationship with Alder Residency
- 3.5 College and Career Readiness: BHA will continue to develop relationships with CSU Stanislaus and the University of the Pacific to offer dual-enrollment courses
- 3.6 Career Pathways: BHA has hired a Pathway Manager and is continuing to foster community partnerships such as San Joaquin A+

- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**
 - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

 - This amount is the total of the Planned Percentage of Improved Services column.
- **8. Total Estimated Actual Percentage of Improved Services (%)**
 - This amount is the total of the Estimated Actual Percentage of Improved Services column.
- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**
