

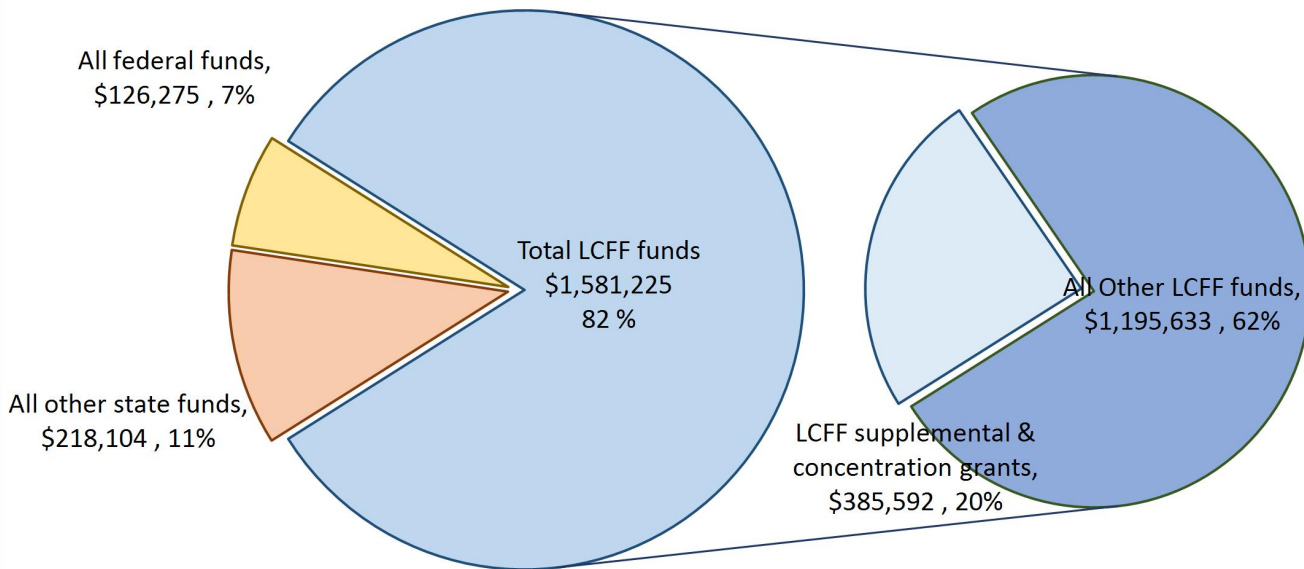

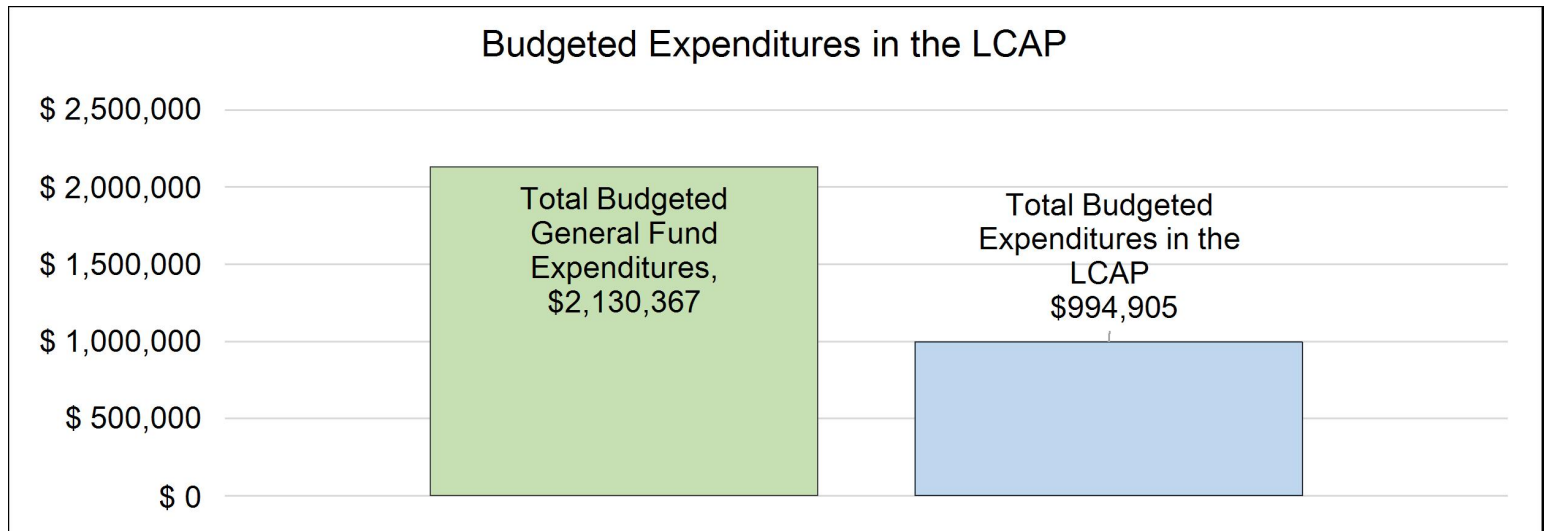

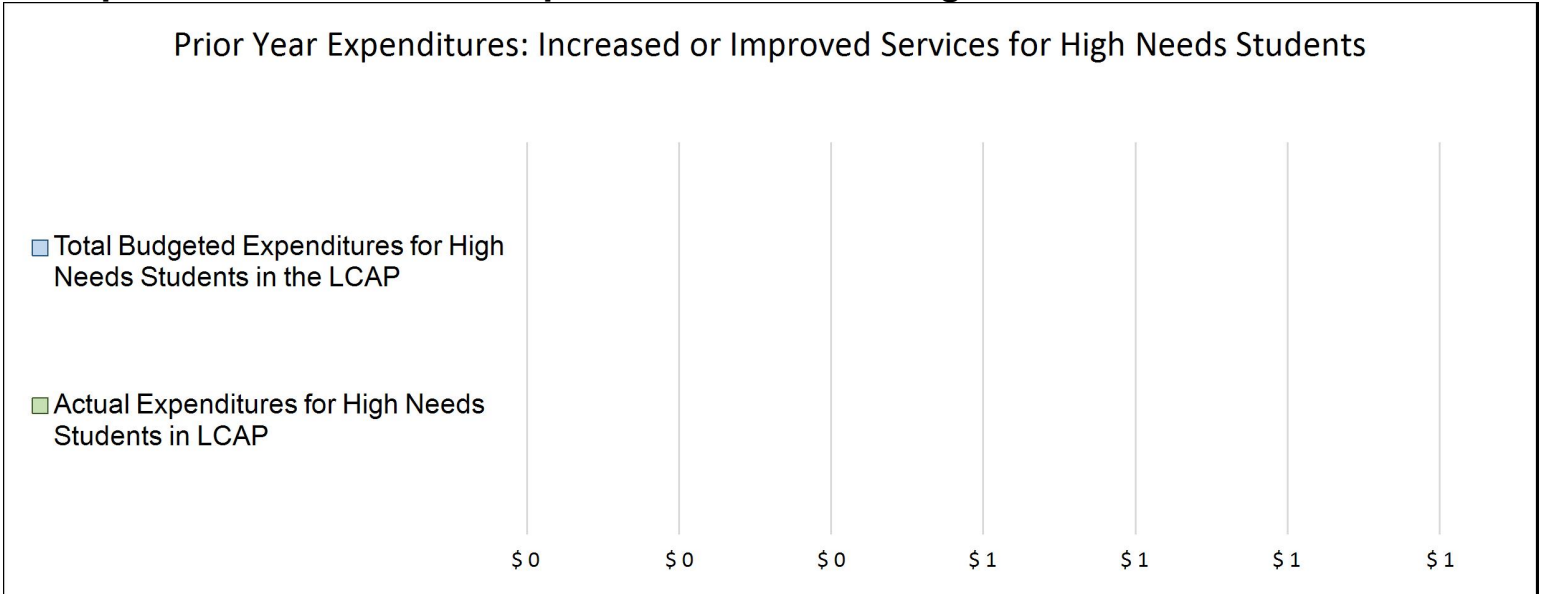

Unbound Stockton Community School will be a 4th - 8th grade public charter school located in the city of Stockton, California. Designed to serve a racially and socioeconomically diverse student body, Unbound Stockton is intentionally “diverse by design,” recruiting students across a broad cross-section of Stockton’s neighborhoods and multiple school districts throughout San Joaquin County. The school’s mission is grounded in equity, academic excellence, and holistic support for all students. Unbound Stockton's instructional approach integrates a rigorous academic experience with a strong community-school model that emphasizes belonging, engagement, and support for the whole child. In Unbound Stockton's founding year, they plan to serve up to 120 students in 4th to 7th grade, and have implemented inclusive recruitment and retention strategies to ensure our school reflects the diversity of Stockton.

Parents & Families	Across four years Unbound Stockton has engaged parents and families in a number of different ways including surveys, focus groups, information sessions, and feedback meetings. The first several strategies were utilized during the charter development phase, and then the informational sessions and family events have been instituted once a month for the past 12 months.
Students	Students have contributed directly to the development of the school model first through a "Leadership Squad" where a group of students met regularly to provide feedback and design elements of the school. Additionally for the past four years, several different curricular pilot experiences were run with students to demonstrate alignment and interest to community related curriculum opportunities.
Teachers & Staff	Teachers were brought on for feedback as the initial development team to design the entire school model. From there many different teachers were consulted during the pre-opening year through collaborative planning sessions, early training engagements, design meetings, and working through curricular pilots during student camps. Teachers also help to pilot writing lesson plans and designing units in preparation for the school opening.
Board Members & Community Partners	Community leaders and board members provided input through strategic planning sessions and charter development working groups and influencing decisions. Furthermore, community partnerships were formed to develop lessons and learning opportunities for students.

Principals, Administrators, and Other Personnel	Collaborative meetings were setup to determine strategic plans to best meet the needs of our community and our goals as a new school. The plans and actions were assessed for feasibility, and areas of actions were prioritized together.

The input of Educational Partners strongly shaped the focus of the school and its goals.

Families and Teachers emphasized the importance of attracting and retaining highly-effective teachers that would teach our students. Introduction and Instructions

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). An action that is limited in its scope is an action that serves only one or more unduplicated student groups.

The LEA reviews the original estimated cost for the action and determines that had it hired additional staff to collect and analyze data and to coordinate supports for students that estimated actual cost would have been \$169,500 due to a cost of living adjustment. The LEA would divide the estimated actual cost of \$169,500 by the amount of LCFF Funding identified in the Data Entry Table and then convert the quotient to a percentage. Contributing Actions Table

- **4. Total Planned Contributing Expenditures (LCFF Funds)**
 - This amount is the total of the Planned Expenditures for Contributing Actions (LCFF Funds) column.
- **5. Total Planned Percentage of Improved Services**
 - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**
 - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

Contributing Actions Annual Update Table

Pursuant to EC Section 42238.07(c)(2), if the Total Planned Contributing Expenditures (4) is less than the Estimated Actual LCFF Supplemental and Concentration Grants (6), the LEA is required to calculate the difference between the Total Planned Percentage of Improved Services (5) and the Total Estimated Actual Percentage of Improved Services (7). - **8. Total Estimated Actual Percentage of Improved Services (%)**
 - This amount is the total of the Estimated Actual Percentage of Improved Services column.
- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**

- If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.

- **13. LCFF Carryover — Percentage (12 divided by 9)**

- This percentage is the unmet portion of the Percentage to Increase or Improve Services that the LEA must carry over into the coming LCAP year. The percentage is calculated by dividing the LCFF Carryover (12) by the LCFF Funding (9).
