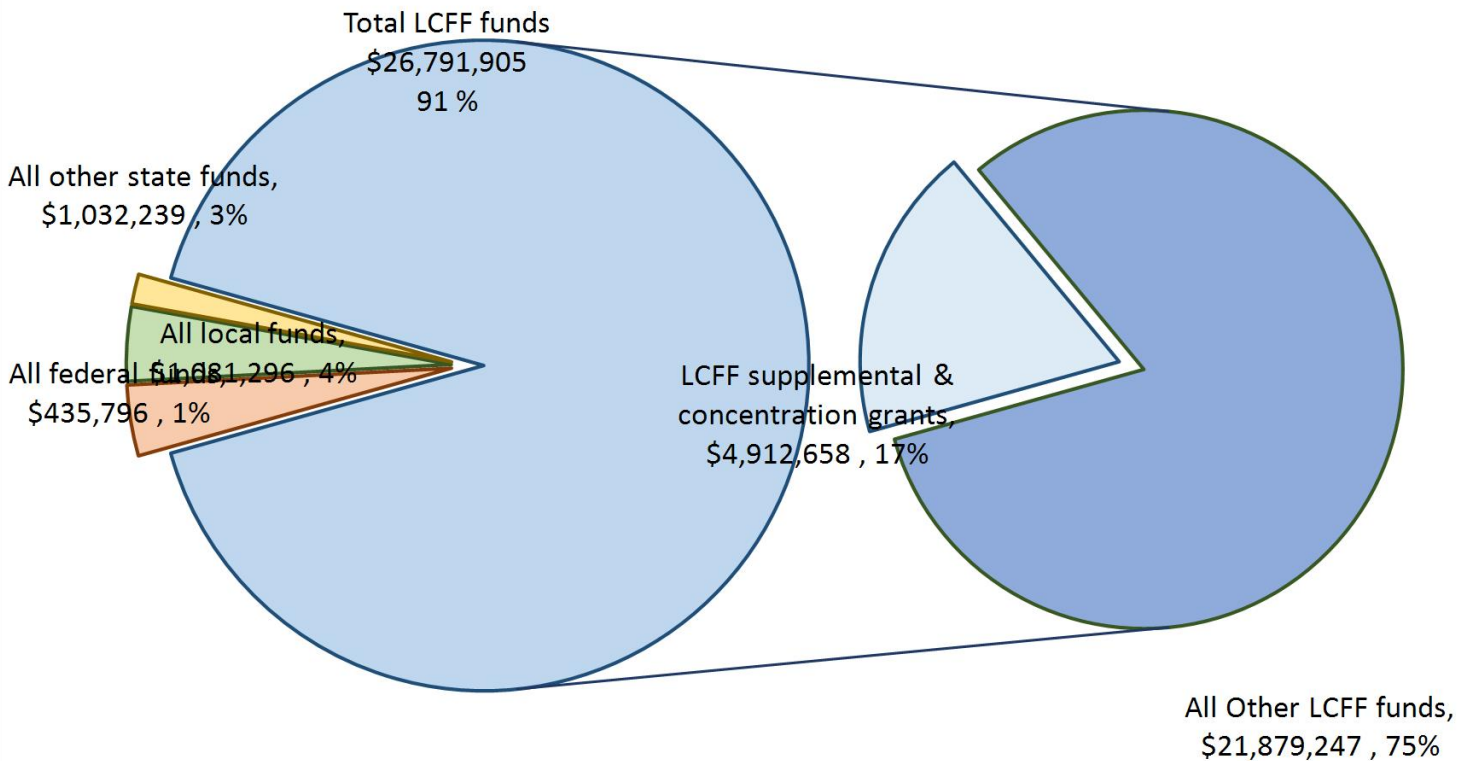

This chart shows the total general purpose revenue Venture Academy expects to receive in the coming year from all sources.

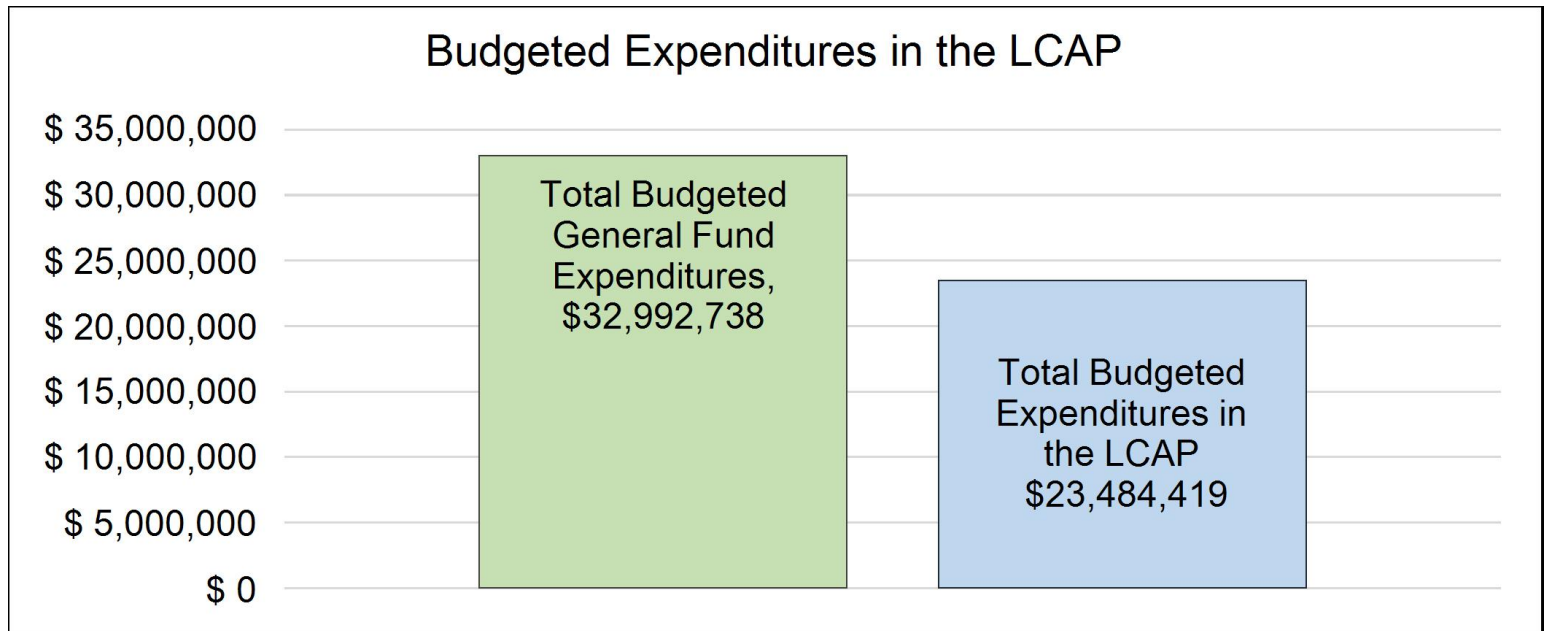
The text description for the above chart is as follows: The total revenue projected for Venture Academy is \$29,341,236, of which \$26,791,905 is Local Control Funding Formula (LCFF), \$1,032,239 is other state funds, \$1,081,296 is local funds, and \$435,796 is federal funds. Of the \$26,791,905 in LCFF Funds, \$4,912,658 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

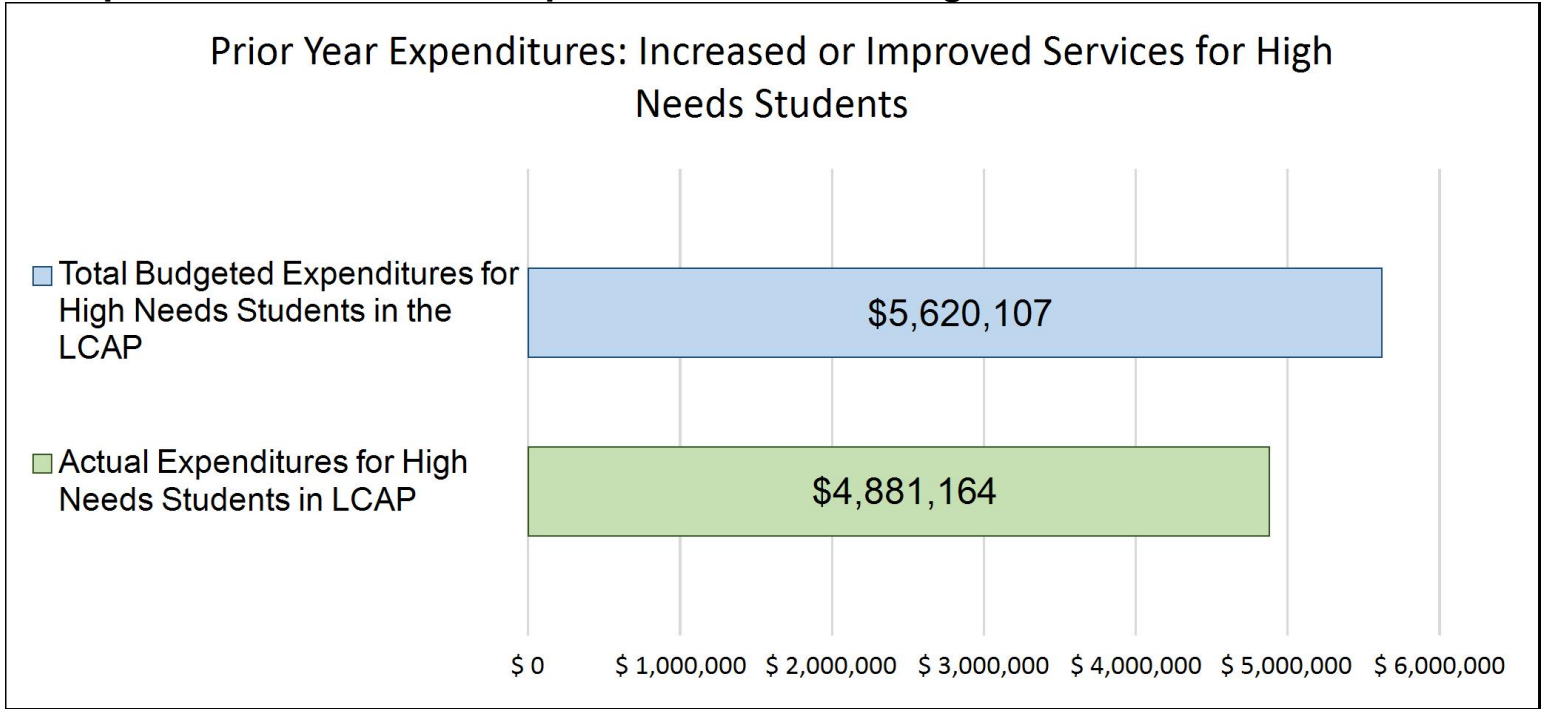

## Increased or Improved Services for High Needs Students in the LCAP for the 2025-26 School Year

In 2025-26, Venture Academy is projecting it will receive \$4,912,658 based on the enrollment of foster youth, English learner, and low-income students. Venture Academy must describe how it intends to increase or improve services for high needs students in the LCAP. Venture Academy plans to spend \$8,673,645 towards meeting this requirement, as described in the LCAP.

The text description of the above chart is as follows: In 2024-25, Venture Academy's LCAP budgeted \$5,620,107 for planned actions to increase or improve services for high needs students. Venture Academy actually spent \$4,881,164 for actions to increase or improve services for high needs students in 2024-25.

The difference between the budgeted and actual expenditures of \$738,943 had the following impact on Venture Academy's ability to increase or improve services for high needs students:

While the actual expenditures for increased or improved services for high needs students were less than the budgeted amount, this difference did not impact the actions and services and the overall increased or improved services for high needs students. We still implemented all our goals and actions. The reason for the difference between the actual expenditures and the budgeted expenditures is that we spent one-time money on some of the increased or improved services.

### General Information

Venture Academy Family of Schools (VAFS) is a WASC accredited charter school of choice authorized by the San Joaquin County Office of Education, located primarily in Stockton, California, with one satellite campus in Manteca, California. Venture Academy serves students from Transitional Kindergarten through twelfth grade. The mission of Venture Academy Family of Schools is to awaken the imagination, passion, dreams and curiosity of TK-12 students by providing rich, standards-based educational opportunities for those who seek innovative, unique approaches to learning. Venture Academy students will become literate, lifelong learners empowered to embrace challenge, think critically, play passionately, live responsibly, and imagine possibilities. Venture Academy provides rich, standards-based educational opportunities that contain innovative, various approaches to teaching and learning. This is reflected in the breadth, depth, and diversity of the school’s curriculum and instructional methods, as well as in the variety of learning environments. Instructional materials, strategies, and activities at all grade levels are aligned to the CCSS.

Venture academy serves the greater population of California's Central Valley. The majority of students are coming from the cities of Stockton and Manteca, but students from all adjacent counties to San Joaquin are able to be in attendance. Students who enroll in Venture Academy may enroll in one of several academies, each with a unique focus. These academies are developed and maintained through small teaching communities. Venture Academy students enrolled in any of the academies are allowed to participate in sports and extra-curricular activities as a student of Venture Academy Family of Schools.

Venture Academy also offers a variety of learning approaches from students attending school in-person four days per week, to home-based programs that are enhanced through a variety of classes and workshops offered to those enrolled. In the model where students attend school

in-person four days per week, students are assigned to one of the school's academies staffed by credentialed teachers. Students receive regularly scheduled instruction, have opportunities to focus on areas of personal interest, and are held responsible for completing off campus educational assignments. All academies provide robust core curriculum, but bring a unique focus to learning that captivates and motivates students to explore, cultivate, develop, and more deeply dive into their interests.

When choosing a home-based program, parents become team teachers with credentialed VAFS teachers. Teachers provide an individualized academic plan, curriculum, and educational assessment of student work. Parents enrich this education plan with home and community projects and are encouraged to use the world as a classroom. Parents who choose this program for their children must be willing to provide the time to be partners in the education of their children. Students enrolled in a home-based academy may have the option to attend onsite classes and workshops. To address individual concerns, teachers may require students to attend specific classes. All students are expected to participate in state mandated assessments.

# Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

## Review of 2024 Venture Academy CA School Dashboard Performance

**English Learner Progress Indicator (ELPI):** Overall performance improved 13.1 percentage points and went from orange to green, with 49.5% of students making progress toward English language proficiency as compared to 36.4% in the prior year. Long-Term English Learners improved 15.7 percentage points with 51.7% making progress as compared to 36% in the prior year.

**Graduation Rates:** Overall performance improved 3.2 percentage points and went from orange to green. with 92.9% of students graduating as compared to 89.7% in the prior year. In addition, graduation rates for Hispanic, Socioeconomically Disadvantaged, White, African American and Students with Disabilities increased.

**Chronic Absenteeism:** Overall performance improved 4.8 percentage points and went from orange to yellow, with 10.9% of students identified as chronically absent as compared to 15.7% in the prior year. In addition, African American, Hispanic, Socioeconomically Disadvantaged, Students with Disabilities, White, English Learners, Two or More Races, and Asians have improved, showing a decline in the percentage of students identified as chronically absent.

**Suspension Rates:** Overall performance improved 3.1 percentage points and went from orange to green, with 3.1% of students being suspended at least once as compared to 6.2% in the prior year. In addition, African American, English Learners, Long-Term English Learners, Asian, Hispanic, Two or More Races, Socioeconomically Disadvantaged, Students with Disabilities, and White student groups have improved, showing a decline in the percentage of students suspended at least once.

**College/Career Readiness:** Overall performance improved 4.9 percentage points with 25.4% of graduates meeting the dashboard requirements to be identified as "Prepared" as compared to 20.5% in the prior year. In addition, Hispanic, Socioeconomically Disadvantaged, Long-Term English Learners, Students with Disabilities and White student groups all showed increases in the percentage of students identified as "Prepared".

**English Language Arts (ELA):** Overall performance as measured by percent of students proficient and above increased by 2.81 percentage points with 35.77% of students showing proficiency as compared to 32.96% in the prior year. When measuring performance by number of points below standard, overall performance declined 3.5 points and went from yellow to orange, with an average of 41.4 points below standard as compared to 37.9 points below standard in the prior year. English Learners, Long-Term English Learners, African American, Socioeconomically Disadvantaged and Asian students all increased, which means they are performing closer to meeting standard.

**Mathematics:** Overall performance as measured by distance from standard improved 2.0 points and maintained red, with an average 111.1 points below standard as compared to 113.1 in the prior year. When measuring performance by percent of students proficient and above, overall performance decreased 0.41% with 10.26% students proficient in math as compared to 10.67% in the prior year. In addition, Asian, English Learners, Hispanic, Long-Term English Learners, Socioeconomically Disadvantaged, and Two or More Races all increased, which means they are performing closer to standard.

Learning Recovery and Emergency Block Grant Funds (LREBG): Venture Academy has no unspent LREBG funds. All funds received by Venture were spent by June 30, 2025, to support student needs.

A description of how the adopted LCAP was influenced by the feedback provided by educational partners.

The feedback from our Educational Partners affirmed that the goals established are appropriate, and that we will continue implementing the actions as aligned with the goals.

Goal 1, Action 1.1 was reaffirmed by engagement with the Venture staff. After analyzing data and reflecting on school improvement initiatives, the Venture Academy staff identified that focusing on grade-level instruction, professional learning around grade level instruction, and time/support to work in content teams to develop high quality grade-level instruction will continue to be a priority.

Goal 2, Actions 2.3, 2.4, and 2.5 were reaffirmed by Venture staff. After analyzing data and reflecting on school improvement initiatives, the Venture Academy staff identified data collection, regular data analysis, training in the use of data, and building systems of academic intervention as a continued priority for Venture. The Venture Academy staff also indicated that increased college and career exploration should be a priority for the school. Engagement with students and parents highlighted the need for additional systems of intervention, with an emphasis on tutoring and academic supports for students who are struggling and for English learner.

Goal 3, and all its actions were reaffirmed by Venture Academy staff, students, and parents. The Venture Academy staff identified continued efforts to improve school safety as a priority, along with building systems of support for student behavior. Students and parents shared feedback that they feel continued efforts to improve school safety, additional mental health supports, and additional activities to promote parent engagement will continue to be a priority.

## Goal Analysis [2024-25]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

All actions were successfully implemented as planned with minimal challenges. Notable successes were identified in the following actions:

Action 1.1 Qualified Staff - We started and have sustained the 2024-2025 school year without any teaching vacancies, allowing students to be taught by a team of credentialed teachers who instruct at grade level and use aligned core curriculum to prepare students for college and career.

Action 1.2 Instructional Materials - Venture Academy has sustained the curriculum adoption process that we established during the 2023-2024 school year. This has enabled us to provide our teachers PD to support their learning of the new curricular materials purchased for math and science. This process has allowed us to improve how we purchase and support instructional materials for the base program, including curriculum for all content areas. The challenges that we faced in building upon our curriculum adoption process is that we found that our implementation year could have benefitted from more training time and practice with the curricular materials prior to full implementation. In addition, some materials came later than anticipated, which resulted in teachers having less time to review and prep the new materials. Both challenges were met by modifying the PD offerings for '24-25 to include additional training time on the new curriculum purchased and improving our curriculum adoption timeline moving forward.

Action 1.5 Professional development, coaching, and training - Venture Academy was able to hire a Literacy Coordinator who has been able to provide professional development, coaching and data driven guidance to support teachers with high quality, research-based instruction intentionally designed to improve students' literacy needs and development, including a specific focus on EL students. In addition, our professional development was focused on grade level content instruction with embedded supports for students, use of data to inform instruction and intervention, and equity.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Action 1.1 - We spent \$645,218 under our budgeted amount because we used one-time funds to cover some of the salaries of qualified staff included in this action.

Action 1.5 - We spent \$286,313 under our budgeted amount because we used one-time funds to cover our professional development contracts and services in addition to the cost for instructional coaching.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Actions 1.1, 1.2 and 1.4 are designed to provide students with access to a high-quality instructional program. This includes curriculum, instructional materials, technology devices, well-trained staff, and facilities. These actions are showing to be effective as the school maintained 100% students with access to standards aligned instructional materials (metric 1B), decreased our number of identified instances where facilities did not meet the good repair standard (metric 1C) and decreased our number of misassigned teaching assignments (metric 1A).

Actions 1.3 and 1.5 were designed to provide additional instructional materials and professional development, coaching and training to improve instruction using standards-based materials and aligned resources. These actions are showing to be effective as the percentage of ALL, SED and EL students who met or exceeded standard on the CAASPP ELA assessment improved (metric 4A ELA). The percentage for SED and SWD who met or exceeded standard on the CAASPP math assessment slightly improved (metric 4A Math). The percentage of EL students who met or exceeded standard on the CAST science assessment increased (metric 4A Science).

All actions were successfully implemented as planned.

Notable successes and challenges were identified in the following actions:

Action 2.1 Support for College Readiness and 2.4 Academic Support and Interventions - Venture added an additional trained counselor to enable additional tier 2 and tier 3 support, advising for credit recovery and summer school, and interventions outside the scheduled school day. We reviewed and updated our a-g course offerings which improved access and consistency in our academic advising for all academies. In addition, Venture Academy covered the cost of at least one academic field trip for each academy to improve college and career readiness access and achievement.

Action 2.3 Student Achievement Data- Despite a staffing vacancy, student achievement data was collected, monitored and analyzed to inform instruction and interventions. Other staff members performed the duties to implement this action.

Action 2.5 Support for English Learners - Venture Academy added an EL team of educators, including the EL teacher, and administrator, the literacy coach, and the parent engagement specialist to focus on supports ELPAC administration, summer learning programs and monitoring of the reclassification process.

Action 2.6 Support for Students with Disabilities - We hired a Special Education Director who provides ongoing support to our instructional staff for students with disabilities, including teachers, speech therapists, school psychologists, paraprofessionals, and administrators.

Action 2.1 - We spent \$123,784 under our budgeted amount because we used one-time funds to cover the salary for the additional trained counselor.

Action 2.2 - We spent \$115,936 over our budgeted amount because we began a construction project to improve our culinary classroom, which will be a one-time expense.

Action 2.3 - We spent \$87,172 under our budgeted amount due to a vacant position.

Action 2.4 - We spent \$141,444 under our budgeted amount because we used one-time funds to provide additional academic support and services to struggling students. We used one-time funds to cover the salaries to implement the action.

Action 2.6 - We spent \$1,619,004 under our budgeted amount because the funding sources we used were not included in the LCAP. We still implemented the action as planned.

## Goal Analysis [2024-25]

All seven actions were implemented as planned with no challenges. Notable successes were identified in the following actions:

Action 3.2 Parent Engagement Efforts - Venture hired a Parent Engagement Specialist who initiated more engagement activities that are inclusive and that provide family support programs and services, such as parenting trainings and support during tiered re-engagement meetings. We added automated translation services which allowed us to translate meetings and provide communications in diverse languages. Venture Academy staff increased our celebrations and recognitions for reclassified students and those who demonstrate the academic ability to speak multiple languages.

Action 3.3 Behavior support and interventions - In an effort to improve our restorative practices, PBIS, and support and communications amongst our engagement partners, Venture provided compassionate dialogue PD to all staff.

Action 3.5 School Safety Team - We changed our survey platform from the Healthy Kids Survey to internal electronic platforms that allows us to customize the language used to best communicate with our educational partners. We are now able to survey our partners more frequently, to support the development of the school safety plan.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Action 3.1 - We spent \$195,312 under our budgeted amount because we used one-time funds to cover some of the salary of our qualified staff to provide mental health supports and interventions.

Action 3.6 - We spent \$90,704 under our budgeted amount because we used one-time funds to cover the salary of the staff to support the school's base nutrition program.

Action 3.7 - We spent \$101,426 under our budgeted amount because we used one-time funds to cover the salary of the additional staff to support the school's nutrition program, primarily to benefit low income students.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Actions 3.1 Support for Student Mental Health and Well Being and 3.3 Behavior Support and Interventions are intended to provide students professional support to address SEL and behavioral needs that are impacting their ability to learn and be productive students. The actions are showing to be effective as the percentage of ALL, SED, EL, SWD and AA students who were suspended at least one day declined (Metric 6A).

Actions 3.2 Parent Engagement Efforts and 3.4 Well-rounded Opportunities are intended to increase attendance which has been effective in decreasing chronic absenteeism rates for ALL, SED, EL, SWD, AA students and students who are identified as two+ races (Metric 5B). They provide outreach, communication, resources, and supports in the family's home language, as well as extra- and co-curricular activities and opportunities to students.

Action 3.5 School Safety Team is intended to provide supervision, support and intervention for all of Venture's educational partners to maintain a safe school environment for all. This action has been effective in that our educational partners: students, parents and staff have

consistently reported feeling safe and connected to school students (Metric 6C). The total number of parents, students, and staff who reported feeling safe and connected at Venture increased and we have now exceeded our targeted outcome for feeling safe for year three by 4% for students, 39% for parents, and 4.2% for staff.

Actions 3.6 Nutritional Services and 3.7 Additional Nutritional Services provide students with a nutritious breakfast and lunch which helps students focus and engage in learning. This action is showing to be effective as the percentage of ALL, SED and EL students who met or exceeded standard on the CAASPP ELA assessment improved (Metric 4A ELA). The percentage for SED and SWD who met or exceeded standard on the CAASPP math assessment slightly improved (Metric 4A Math).

An abbreviation key was added to the explanation of why we are implementing this goal. Metrics descriptions were updated to include abbreviations. Action 3.7 (Additional Nutritional Services) is being eliminated. The service is included in Action 3.6 (Nutritional Services). Based on staff and union feedback, one of the questions in the staff connectedness survey in metric 6C was eliminated as it was too vague. The question eliminated was phrased, "Our school reflects a sense of community". The other two questions on the staff perception survey have remained the same and can still be used to gauge staff connectedness.

Venture Academy used the 15% concentration grant add-on funding to support socio-economically disadvantaged students, foster youth, and English learner students in the following ways:

- K-8th grade PE Teacher Salary (Action 3.4) to support K-8th grade extra-curricular and sports activities to help maintain student engagement.
- CTE Teacher Salary (Action 2.2) to encourage pathway development and a variety of career pathway options.
- CTE Teacher Salary (Action 2.2) to encourage pathway development and a variety of career pathway options.

The PE teacher provides direct instructional services to students and meets the needs of our socio-economically disadvantaged, foster, and English learner students by incorporating life skills into the curriculum, incorporating health, nutrition, and wellness into the curriculum, and exposing students to a variety of sports while building foundational skills for students to be involved in extra-curricular activities, which helps students stay connected to school, improve attendance, and improve academic learning.

The two CTE teachers provide direct instructional services to students and meet the needs of our socio-economically disadvantaged, foster, and English learner students by exposing them to a variety of elective subjects that are connected to high-skill, high-wage careers. CTE courses also embed the soft skills needed to be successful in a job and a career. Enrollment in a CTE pathway increases student engagement in school, connection to their future goals and careers, and provides hands-on learning that is engaging and motivating for

students, thus increasing attendance, academic performance, and career readiness.

- **LCFF Carryover — Percentage:** Specify the LCFF Carryover — Percentage identified in the LCFF Carryover Table from the prior LCAP year. If a carryover percentage is not identified in the LCFF Carryover Table, specify a percentage of zero (0.00%).
- **Total Percentage to Increase or Improve Services for the Coming School Year:** This percentage will not be entered; it is calculated based on the Projected Percentage to Increase or Improve Services for the Coming School Year and the LCFF Carryover —

Percentage. ***This is the percentage by which the LEA must increase or improve services for unduplicated pupils as compared to the services provided to all students in the coming LCAP year.***

- **Goal #:** Enter the LCAP Goal number for the action.
- **Action #:** Enter the action's number as indicated in the LCAP Goal.
- **Action Title:** Provide a title of the action.

  - This amount is the total of the Planned Expenditures for Contributing Actions (LCFF Funds) column.
- **5. Total Planned Percentage of Improved Services**
  - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**
  - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

### **Contributing Actions Annual Update Table**

Pursuant to EC Section 42238.07(c)(2), if the Total Planned Contributing Expenditures (4) is less than the Estimated Actual LCFF Supplemental and Concentration Grants (6), the LEA is required to calculate the difference between the Total Planned Percentage of Improved Services (5) and the Total Estimated Actual Percentage of Improved Services (7).   - This amount is the total of the Estimated Actual Percentage of Improved Services column.
- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
  - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

## **LCFF Carryover Table**

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
  - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
  - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**

- If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9).
