(b) applies which, if discussed in public, would be likely to have a substantial adverse effect upon the reputation of any person referred to in such histories or data, or involved in such problems or in investigations; and Wis. Stat. Section 19.85(1)(g) to confer with legal counsel for the governmental body who is rendering oral or written advice concerning strategy to be adopted by the body with respect to litigation in which it is or is likely to become involved: specifically to discuss (1) an appeal of a parent discrimination complaint filed under District Policy BBDI, Public Concerns and Complaints and District Procedure BDDI-R(1), Procedures for Responding to Public Concerns and Complaints; and (2) to conduct the District Superintendent's Mid-Year reflection pursuant to Board Procedure 12, Superintendent Evaluation and (3) a pending employment investigation.
