4. Review Policies:

a. Draft of File IKF - Competency Determination Graduation Requirement

- New state requirements that added more specific requirements to the policy. They require one less history class than our prior policy. Policy must be ready for December 1st. Feedback is needed from the school committee - are there courses that we need to say students must complete? Ex: do we need to say they must complete Biology 1 and Biology 2?
- High school administration has expressed comfort with the new policy as it provides more pathways for students.
- Subcommittee suggested additional edits. Policy will come back to subcommittee on 10/14/23 and should be ready for first read at MRSC meeting on 10/23/25.

b. File IM-MSP - Middle School Pathway Exploration Policy

- State requires schools to have a policy that we inform middle school students of technical pathways. This is something MRMS already does. Policy due to the state Nov 1st.
- 8th graders are already at the high school and already engaged in the pathways. As we implement the policy, we may need to revise the policy next year based on what we learn.
- Move to MRSC for **first read on 10/9**.

c. File BEDC: Quorum

- Reminder to MRSC on the second paragraph - if there is ever a need to discuss changes to elementary schools, we will need all hands on deck.
- No changes to this policy - move to MRSC for **vote on 10/9** (reviewed, no changes)

d. File BEDD: Rules of Order

- Revised policy to add MASC language. Move to MRSC for **first read on 10/9**.

e. File BEDF: Voting Method

- MASC language added to policy. Move to MRSC for **first read on 10/9**.

f. File BEE: Special Procedures for Conducting Hearings

- MASC language added. Move to MRSC for **first read on 10/9**.

g. File BGB/BGC: Policy Adoption/Policy Amendment

- MASC language update, minor edits from subcommittee. Ratification process= policy review process. Move to MRSC for **first read on 10/9**.
